1. **Community Planning and Partnerships Guideline**

Superintendent Cayen-Arnold reviewed the revised Community Planning and Facilities Partnerships administrative procedure. This administrative procedure is being updated to reflect new guidelines issued by the Ministry of Education in March 2015.

The Community Planning and Facilities Partnerships administrative procedure provides guidelines for consultation to share facilities with community partners when building new schools, undertaking significant additions and/or renovations, or considering the use of underutilized space in schools.

Trustees asked questions and received clarification.

2. Student Accommodation

Superintendent Cayen-Arnold explained that this policy is being updated to reflect new guidelines issued by the Ministry of Education in March 2015. The Student Accommodation policy outlines the process and timelines for accommodation reviews that may be initiated when Board decisions require the consolidation, closure, or relocation of a program or school due to changes in program demands, student enrolment, community demographics, capital needs of the school, and other factors.
