Title:	Bill 20: Ryan's Law – Ensuring Asthma Friendly Schools 2015

Mandate	Bill 20: Ryan's Law requires Rainbow District School Board to establish and maintain a procedure for students diagnosed with asthma. The procedure will outline the Board's commitment to students with asthma.
Background	Bill 20: Ryan's Law was passed on April 30, 2015. The Bill requires school boards to establish an asthma procedure including strategies to reduce the risk of exposure to asthma triggers, a communication plan for sharing information about asthma and regular training on recognizing and managing asthma symptoms. Schools are required to develop an individual plan and maintain a file for each student with asthma. It is the obligation of the pupil's parent or guardian to ensure that the information in the pupil's file is kept up-to-date with the medication that the student is taking. With the parent or guardian permission, students under the age of 16 shall be permitted to carry their asthma medication. Students 16 years of age or older do not require parent or guardian permission to carry their asthma medication. Effective September 8, 2015.

3. **Director's Remarks**

On Monday April 13 I had the good fortune to attend and present awards at the Kiwanis Music Festival, held at St. Andrews United Church. Rainbow District School Board was well represented as Copper Cliff PS, MacLeod PS, Lasalle SS and Lively DSS provided wonderful musical performances. Awards were presented to all of the above as well as Assiginack PS.

Special thanks goes out to teachers Marc Savard, Mike Jensen, Val Whitehead, Cory Ross, Jack Broumpton and Ray Scott for being such great advocates for our students and their schools.

On Wednesday, April 22 I met with Robert Beaudin in M'Chigeeng. This is a follow up to our February 20th meeting where we established joint understanding and a

commitment to build a better understanding of First Nations partners. To reinforce our commitment to build stronger connections with our FNMI partners, Director of Education Beaudin took great lengths to show physical evidence of the many attributes his community has to offer. His tour of M'Chigeeng was very educational and greatly appreciated. We agreed to continue to explore many other areas where we could find common ground.

On Monday April 27, I attended the Learning Disabilities Association (LDAO) presentation at Cambrian College to hear Rick Lavoie's message on students who "Learn Differently" and strategies to help them find academic and social success. The event was well attended and the public received a great message. His presentation was live streamed to Espanola and Manitoulin Island. RDSB received recognition, by the host Ron Lessard, who presented us with a plaque.

Earlier in the day Rick Lavoie hosted several hundred teachers and educational assistants as he played an integral part of our professional development offering.

On Monday, April 27 all grade Grades 7 and 8 teachers received Physical and Health Education Curriculum Training, OPHEA.

5. **Chairperson's Remarks**

The Ontario Secondary School Teachers' Federation - District 3 began legal strike action on Monday, April 27, 2015. As a result, Rainbow District School Board has cancelled all instructional programs for students in Grades 9 to 12. Secondary schools will be closed to students until further notice.

During the labour disruption, it is important that students continue to complete work they have been assigned and prepare for their final evaluations. Students and parents/guardians should work on the assumption that school will resume and studies will continue.

Four young scientists from Rainbow Schools earned the privilege of competing at the Canada-Wide Science Fair in Fredericton, New Brunswick from May 14 to 16, 2015.

Mia Pandolfo, a Grade 12 student from Lockerby Composite School, developed a smartphone application that allows patients to track and record chronic pain episodes.

Grade 8 student Alyssa Gran of Algonquin Road Public School investigated ways to mitigate the effects of cancer-causing radon gas penetration into residential and/or commercial properties.

Ethan Albers and Jacob Little, Grade 7 students from Algonquin Road Public School, developed an inexpensive and labour-friendly ultrasound device that measures the thickness of ice on water bodies.

All of these students won numerous awards at the Sudbury Regional Science Fair and we are very proud to have them represent Rainbow District School Board at the national level. Our best wishes to each of them.

2. **Welcome:** Chair Tonya Marcotte

Chair Tonya Marcotte welcomed everyone to the meeting, invited PIC members to introduce themselves, and introduced the guest speaker.

3. Presentation on Growth Mindset

by Superintendent Judy Noble and Curriculum Co-ordinator Cheryl Geoghegan

Each member was given a dot-to-dot drawing to complete. The drawings, of varying degrees of difficulty, were designed to illustrate how we respond when we are given a task that exceeds our abilities.

Superintendent Judy Noble said babies are born innately curious. About 95 per cent of Early Learning Kindergarten students are fully engaged. By Grade 9, this drops to 37 per cent. Approximately 17 per cent of students don't graduate. There are biological reasons why students become disengaged as they age, such as hormones and sleep patterns. The biggest factor, however, is mindset. Your mental attitude determines how you interpret and respond to situations.

At one time, it was thought that everyone was born with a certain level of intelligence. Recent brain research, however, has changed that perception. The theory today is that mindset matters. Your brain is a muscle that can grow and change. Every time a student works hard and perseveres to learn something new, his or her brain forms new connections. As a result, any student can achieve at the highest level.

To develop a growth mindset, students, teachers and parents need to understand three steps: Step 1 - Learn, Learn, Learn; Step 2 - Realize hard work is key; Step 3 - Face setbacks.

If we value and promote a strong work ethic, students will be more willing to persevere when tasks become more difficult. A collaborative inquiry determined that teachers need to praise mistakes and help students understand that their approach to problems matters. Teachers need to encourage students to attempt more challenging tasks, provide praise for the difficulty of the tasks chosen and provide ongoing feedback. Students need to believe that they have the ability to accomplish the task.

Members were invited to complete an exercise at home and record how they praised their children, to determine if the praise followed a growth mindset or fixed mindset. They were then encouraged to make an effort to shift to a growth mindset.

Parents were excited about the growth mindset concept in schools and asked how it was being implemented. Superintendent Noble explained that there is funding available for teachers to take the Dr. Jo Boaler online math course. It is also a topic at learning cycles for Grades 7 to 12.

6. Discussion based on the presentation

During the presentation, members discussed how to reach parents to ensure they understand the growth mindset model. Various ideas were presented, including recording PIC meetings and having them available online for parents to access, using the PIC PRO Regional Grant to create growth mindset newsletters, and providing parents with other growth mindset resources.

Bernadette Rémillard asked what a parent can do if they have a student who is struggling, even when the student has a great teacher and tutor. Superintendent Noble suggested several strategies, such as documenting growth, praising things that encourage the student to keep trying, and sharing research on brain development with the student.

Karla Allen wanted to know if the brainology.com web address would be added to the website. Judy Noble advised that she would look into this.

Nicole Charette discussed creating a page within the Parent section of the Rainbow District School Board website for information on Growth Mindset and myBlueprint.

7. Communications Report

Nicole Charette delivered the communications report.

Rainbow District School Board's Executive Council is recommending that the magnet programs in Rainbow secondary schools be maintained with busing. Magnet programs include the Arts Education Program at Sudbury Secondary School, the Science Technology Education Program at Lockerby Composite School, the International Baccalaureate Program at Lo-Ellen Park Secondary School and the Integrated Technology Program at Lively District Secondary School.

The recommendations, presented at the Strategic Planning Committee meeting on Tuesday, February 10, 2015, follow the findings of an in-depth review. The review, carried out through the lens of student achievement and well-being, included a third party analysis of student achievement data and transportation costs as well as information gathered from principals, School Council Chairs, students and teachers.

The report on magnet programs in the Rainbow District School Board and Executive Council's recommendations can be accessed on the Board's website. The public will have an opportunity to make presentations at the regular meeting of the Board on Tuesday, February 24, 2015 as well as the Strategic Planning Committee meeting on Tuesday, March 10, 2015. At this meeting, the Strategic Planning Committee may forward motions regarding the magnet programs to the Board for consideration. The motions will be considered at the Board meeting on Tuesday, March 24, 2015.

Rainbow District School Board will begin a feasibility study on the consolidation of educational support services. The study will be complete no later than January 2016. Educational support services are currently dispersed across a number of locations. For financial reasons, only current Board properties will be reviewed for the consolidation of educational support services.

Information Nights continue at Rainbow secondary schools, including Lively District Secondary School on Wednesday, February 18, 2015 at 6:30 pm and Manitoulin Secondary School on Wednesday, February 25, 2015 at 6:30 pm. Registrations continue for Early Learning - Kindergarten (ELK). ELK orientation sessions will be held this spring.

The Joan Mantle Music Trust Steering Committee will soon announce the 2015 recipient of the Joan Mantle Music Trust Community Award. The award will be presented at the International Dinner and Silent Auction in support of the Trust on Saturday, March 28, 2015 at 6 pm at the ParkSide Older Adult Centre, 140 Durham Street, in Sudbury. All proceeds will go towards the purchase of new instruments in Rainbow Schools. For more information, visit rainbowschools.ca.

Rainbow Schools participated in Eat Local Day on Thursday, January 22, 2015 and Sweater Day on Friday, February 13, 2015 as Rainbow District School Board continues to focus on education for sustainable development. Students and staff will be invited to participate in Earth Hour in March.

System-wide events for students begin soon. Grade 7 and 8 students will participate in Rainbow District School Board's annual Elementary Science Fair on Friday, February 27, 2015. Up to 37 projects will be selected for the Sudbury Regional Science Fair being held at Laurentian University's Alumni Hall on March 28 and 29, 2015.

Rainbow District School Board will host its tenth annual Technological Skills Competition at Cambrian College on Wednesday, March 4, 2015. Over 120 secondary school students will test their skills in events such as carpentry, welding, fashion, TV/video editing, photography, autoservice technology, 2D character animation, cabinet making and small-powered equipment. Students will vie for an opportunity to compete in the provincial Skills Competition in Waterloo this May.

Invitation for Input into Special Education Programs and Services for 2015-2016 The Board has received 170 paper copies and 20 online responses. There were 2458 invitations sent which is a 7.7% response rate. Of the responses received, 54 paper and 12 online had additional comments and suggestions. Follow up with individual schools is completed when individual schools are identified in the survey. Parent engagement is a challenge.

VTRA and RMT Data

During the 2014-2015 school year to date, the Board has been involved in 16 VTRA meetings – 10 initiated by the RDSB, 3 by police for RDSB students, and 3 from coterminous boards for students who previously attended school in the Board. The Board also participated in 50 RMT situations – 19 of which involved RDSB students. Of those 19, 8 were initiated by the RDSB and our community partners initiated 11 others.

Updates

An offer of employment has been made to Allison Orford for the Espanola and Manitoulin social worker position.

Senior Administrator Wachnuk will ask Christine McInnes to present to the SEAC the role and work of a social worker in the Board.

The Board is in the process of renewing Section 23 program agreements with other local agencies. The Lansdowne PS and Northeastern ES S23 program agreements with CFC will not be renewed; however, the Board will maintain the classes as self-contained programs using existing staff supports already available. New agreements in development will allow for the creation of new programs to meet current challenges.

Special Education Supports for Adult Education Students

The Board does not have any students with an exceptionality currently enrolled in adult education. Any student requiring the use of assistive technology could have access to it.

Updates

The Board has approved the continuation of the four secondary school magnet programs to be reviewed again in five years. The Board will work with schools and staffs to make schools not offering magnet programs more competitive.

The Board is anticipating a continuation of funding through the Ministry's 21st Century Teaching and Learning Initiative, which has been in place for the past three years.

The Ministry announced the 2015-2016 Grants for Student Needs. The Board is in the process of reviewing what impact it will have on programs and services for next year.
