The Summer Program for Students with Autism Spectrum Disorder will be offered at Princess Anne Public School while the Summer Social Emotional Program at Jean Hanson Public School will provide students with the opportunity to enhance their social skills in a supportive environment.

Summer School programs at the secondary level begin on July 2, 2015. Remedial classes take place at the Adult Day School at Sudbury Secondary School.

## **RAINBOW DISTRICT SCHOOL BOARD BORROWING RESOLUTION**

### A RESOLUTION AUTHORIZING THE BORROWING OF MONEY TO MEET CURRENT EXPENDITURES OF THE RAINBOW DISTRICT SCHOOL BOARD (THE "Board")

- A. In accordance with Subsection 243(1) of the Education Act (R.S.O. 1990) (the "Act"), the Board considers it necessary to borrow the amount of up to Seven Million Dollars (\$7,000,000) to meet, until current revenue is received, the current expenditures of the Board for the period commencing on September 1, 2015 and ending on August 31, 2016 (the "Period").
- B. Pursuant to Subsection 243(3) of the Act, the total amount borrowed pursuant to this Resolution together with the total of any similar borrowings and any accrued interest on those borrowings is not to exceed the unreceived balance of the estimated revenues of the Board for the Period.
- C. The total amount previously borrowed by the Board pursuant to Section 243 that has not been repaid is \$0.
- D. The amount borrowed for current expenditures is within the Board's Debt and Financial Obligation Limit as established by the Ministry of Education from time to time.

#### RESOLVED THAT:

- 1. The Chair or Vice Chair and the Treasurer are authorized on behalf of the Board to borrow from time to time by way of promissory note, or overdraft, or bankers' acceptance from Canadian Imperial Bank of Commerce ("CIBC") or from any other approved lender authorized for borrowing purposes in accordance with Section 243 of the Act a sum or sums not exceeding in the aggregate Seven Million Dollars (\$7,000,000) to meet, until current revenue is collected, the current expenditures of the Board for the Period (including the amounts required for the purposes mentioned in Subsection 243(1) and 243(2) of the Act), and to give to CIBC or to any other approved lender promissory notes or bankers' acceptances, as the case may be, sealed with the corporate seal of the Board and signed by any two of the Chair or Vice Chair and the Treasurer for the sums borrowed plus interest at a rate to be agreed upon from time to time with CIBC or any other approved lender;
- 2. The interest charged on all sums borrowed pursuant to this Resolution plus any related charges, is not to exceed the interest that would be payable at the prime lending rate of the chartered banks listed in Schedule 1 of the Bank Act (Canada) on the date of borrowing;
- 3. The Treasurer or Deputy Treasurer is authorized and directed to apply in payment of all sums borrowed plus interest, all of the moneys collected or received in respect of the current revenues of the Board;
- 4. The Treasurer or Deputy Treasurer is authorized and directed to deliver to CIBC or any other approved lender from time to time upon request a statement showing (a) the total amount of unpaid previous borrowings of the Board for current expenditures together with debt charges, if any, and (b) the uncollected balance of the estimated revenues for the current year or, where the estimates have not been adopted, the estimated revenues of the previous year less any current revenue already collected.

**RAINBOW DISTRICT SCHOOL BOARD**

**BY-LAW NUMBER: 2015-01**

A BY-LAW authorizing the Rainbow District School Board (the “Board”) to borrow money pursuant to the provisions of section 247 of the Education Act (the “Act”) for the raising of funds to finance certain permanent improvements as more particularly described in this By-Law.

**WHEREAS:**

- A. The Board has authorized the permanent improvements under the:  
Capital Priorities Program and Full Day Kindergarten Capital Allocation (Consolidation of A.B. Ellis Public School into Espanola High School) - \$4,664,000 and  
School Condition Improvement Funding Program - \$5,257,000
- B. The Board wishes to apply to the Canadian Imperial Bank of Commerce (“CIBC”) for a short term capital loan through the purchase of Bankers Acceptance for the purpose of financing the permanent improvements;
- C. The total cost of the projects is within the Board’s Debt and Financial Obligation Limit as established by the Ministry of Education.

**THEREFORE, BE IT RESOLVED** as follows:

- 1. The Treasurer and the Deputy Treasurer of the Board are authorized on behalf of the Board to borrow \$9,921,000 for permanent improvements in accordance with the Act, plus interest at a rate to be agreed upon from time to time with the CIBC and consistent with the short term borrowing direction provided by the Ministry of Education.
- 2. The Treasurer and the Deputy Treasurer are authorized for and on behalf of the Board to execute and deliver all such other documents and to do such other acts and things as may be necessary to give full effect to this By-Law.

RAINBOW DISTRICT SCHOOL BOARD

The success of the Ontario Public School Boards' Association (OPSBA) is strengthened by the commitment of our members to the value of publicly funded education. We appreciate this opportunity to share with you the benefits of OPSBA membership and some highlights of our work this past year that we have undertaken to support you in your roles.

OPSBA's chief role is supporting our school boards, Ontario's only democratically elected bodies with specific responsibility for the education and well-being of our children and youth. We strive to represent the many divergent and unique interests of our members and, in so doing, we demonstrate that we can collectively influence education policy and advocate for investment in education in Ontario. As a representative organization, governed by our members, we take our lead from you and work to support you in fulfilling your mandates to your students, parents, staff and community.

We invest our expertise and energy in ways that we know will have positive impacts on a wide variety of student needs across the province. Our voices at the tables dealing with current education initiatives are always rooted in our five priorities:

- The Whole Child and Student Well-Being
- New Generation Education
- Trustees – Building Leadership Capacity
- Education Funding
- Labour Relations

Throughout the past year, we were proactive in dialogues with the Minister of Education and Ministry staff in addressing education funding issues identified by Member Boards. While recognizing the economic challenges facing the government, OPSBA advocated for commitment to funding for mental health supports and services, student transportation, special education and capital funding. We renewed our recommendation for ongoing review of the funding model as a whole. When it comes to implementation of funding we maintained close communications with member boards with regard to the local impact of funding changes and engaged with the Ministry on issues arising out of implementation.

We continue to be a leader in the Coalition for Children and Youth Mental Health, a diverse multi-sectoral body that continues to grow in status. It is now recognized as a key resource to the Ministries

charged with implementing the province's mental health strategy. The fourth Summit on Children and Youth Mental Health will be held on April 7 and 8, 2016.

Our First Nation Trustees Council provides a strong voice in advocacy for First Nation, Métis and Inuit (FNMI) education. The Council has engaged in a range of initiatives to support FNMI education this year, including co-chairing the Ministry work team that drafted the implementation plan for Ontario's First Nation, Métis and Inuit Education Policy Framework. The Council is engaged in ongoing advocacy work with regard to Ontario's curriculum and OPSBA has been pleased to have the support of our member boards in this endeavor.

Trustees who are skilled and knowledgeable in their complex governance and leadership roles make for strong and effective school boards. Our multi-year priority on building trustee leadership capacity continues to focus on resources that support trustees as education leaders. The resource *Good Governance: A Guide for Trustees, School Boards, Directors of Education and Communities* was updated in time for October's Municipal and School Board Elections. Four new professional learning modules for trustees and school boards have been developed – What Makes a Great Board Chair?, First Nation, Métis and Inuit Education, Code of Conduct, and Social Media. These will be available online this summer.

Prior to the Municipal and School Board Elections, we advocated on issues affecting the governance role of the trustee. We took the lead with partner school board associations, with support from the Ministry, to develop a number of resources, including a first-of-its-kind school board election website at [elections.ontarioschooltrustees.org](http://elections.ontarioschooltrustees.org). Following the election, we worked with the Ministry of Education's Leadership and Governance Branch to offer a comprehensive orientation for incoming trustees in conjunction with the 2015 Public Education Symposium.

The 2014-15 school year marked OPSBA's first year as designated employer bargaining agent for Ontario's English Public School Boards under the *School Boards Collective Bargaining Act, 2014*. Governed by OPSBA's bargaining mandate "to negotiate fair, equitable and fully funded collective agreements to ensure positive learning conditions that promote student achievement, success, learning and well-being for all students," our staff continues to work with our member boards to represent the interests of students and school boards in central discussions. We are deeply appreciative of the collaborative contributions of staff from our member boards – it is a partnership that ensures a deep level of expertise and a range of perspectives that covers the province.

A current initiative from the Premier's office focuses on developing a framework for community hubs which has implications for the use of school space. We have participated in conversations regarding community hubs at all levels of the organization and continue to advocate for increased and sustained collaboration among school boards, community agencies and municipal governments, including promoting the value of schools as community hubs.

Our programs and services are highly cost effective. The financial benefits of membership far exceed not only the membership fee itself, but the outcomes that could be achieved by boards acting individually.

OPSBA continues to work at a national level on interventions that have an impact on copyright tariffs with the goal of ensuring fair dealing for school boards. This has been successful and has resulted in substantive savings for our member boards.

Through the Ontario Education Services Corporation (OESC), we are active in interventions at the Ontario Energy Board on behalf of Member Boards. Interventions on natural gas rates and electricity rates have continued to create significant savings for all school boards - **\$30.6 million** in 2014-15 alone.

Savings in the areas of copyright and energy interventions for the past year cover membership fees many times over. When this is combined with the indirect benefits created by OPSBA coordination and advocacy identified in this correspondence, the value of membership speaks for itself.

Highlighted below are last year's savings realized in the area of copyright and energy intervention alone.
