4. Director's Remarks

The Director received notice from CFC indicating that: Child and Family Centre and the respective Union Local OPSEU 666 reached an agreement over the holidays so many of our Section 23 classes, partnered with CFC, will resume normal intake processes.

We have confirmed with Sudbury Theatre Centre that we will be sponsoring a school matinee called the #Watertower. Abstract: "Tom and Emma were the perfect couple. Then a provocative image of a teen girl hits #TheWatertower, an online social network. Will the fabric of an entire community unravel overnight? Four teens each must separately navigate these dangerous digital waters as they learn how they will stand up for themselves, and one another. Will anything ever be the same? #TheWatertower is an exciting live theatre and interactive digital experience about the important issue of cyberbullying – How we treat others as we live in our social spaces, both real and virtual."

The performance will target grades 7-12 and will begin on April 1 and conclude on April 8, 2016. Transportation to outlying areas will be subsidized. I encourage all trustees to attend. Please let Heather know if you intend to go.

We met with our stakeholder groups for the school year calendar on January 13, 2016. At that time I informed them that we would be adding February 29th as an additional PD day for the 2015-2016 school year. Since then we have had to reschedule the date to Friday, May 20, 2016. This is as a result of a request from two coterminous boards.

International trips – 3-month embargo in France.

We are monitoring trips. We expect tour companies to be working with school organizers if trip agendas are to be revised. Two of our schools, Chelmsford Valley District Composite School and Lockerby Composite School are affected. The advisory for France is very clear as stated by the Canadian Government trip advisory as of January 26, 2016: *"Following the November 13, 2015 attacks"*

in Paris, the French authorities have raised the Vigipirate alert to the highest level (terrorist alert) and have declared a country-wide state of emergency. Controls have been reinstated at points of entry, enhanced security measures have been put in place at airports, curfews could be imposed in certain areas, traffic could be restricted in some neighbourhoods and there could be disruptions to public transportation in Ile-de-France. Due to the state of emergency, there is a heightened potential for police raids to take place. If you are in an area where a police raid is being conducted, remain indoors, close all windows and blinds, and stay away from windows. Exercise a high degree of personal security awareness, maintain a heightened level of vigilance and be aware of your surroundings at all times."

On January 21, 2016, Superintendent Dye and Acting Vice Principal Kelly McCauley presented RDSB Math Apps to the Council Of Directors of Education and to Superintendents of Business at the CEO-CFO Annual Conference of 2016 in Toronto. All 72 boards were present. They were excellent!

Kris Longston from the City of Greater Sudbury has confirmed he will present population data for the City of Greater Sudbury at the March 8, 2016 meeting of the Strategic Planning Committee.

Special Incidence Portion (SIP) Applications

SIP applications for 197 students have been submitted to the Ministry for \$3.8 million. The Board received \$2.8 million in SIP funding from the submission for 2015-2016.

<u>Violent Threat Risk Assessment (VTRA) and Rapid Mobilization Table (RMT)</u> VTRA is a reactive process and the RMT is meant to be proactive. Both processes will access community-based intervention. The Board has opened 14 VTRA processes and referred 15 cases to the RMT since September 2015. Sue Del Riccio, Itinerant Teacher, is the Board's RMT representative and has been involved with 35 cases referred within the community to the RMT.

Superintendent Wachnuk will ask Amber Perry, Chief Psychologist, to determine if provincial funding for the RMT is being reduced.

Lexia Reading Program

The Board purchased an additional 100 licenses in December to support approximately 1700 students using the Lexia program. The majority of students using the program attend Grades 3 to 8. Students attending an ISP as well as English Language Learners also use Lexia. The first Syrian family has arrived and their children are attending CR Judd. Another family will be arriving next week with students attending Confederation Secondary School.

Child and Family Centre (CFC) Labour Dispute

CFC has announced that the pending labour dispute has been resolved.

RDSB Annual Report 2014-2015

Superintendent Wachnuk distributed and highlighted sections of the recently released report.

11.0 Special Education Staff Report

Itinerant Teachers of the Blind

The Board has hired a qualified and experienced teacher from outside the Board to provide supports for children in the Espanola and Manitoulin areas.

February 5 PD Day

Teachers will be involved in assessment and evaluation. Training in Behaviour Management Systems and First Aid will be provided for Educational Assistants.

Predicted Enrolment

Consultants and Coordinators have begun gathering data for predicted enrolment and special education staff planning for 2016-2017.

Special Education Plan

The plan is currently under review. The document will be prepared with a unifying style, font, and format for 2016-2017.

12.0 Board Report

<u>Updates</u>

Trustees Doreen Dewar and Dena Morrison were acclaimed as Chair and Vice-Chair of the Board for 2016. Trustees Judy Kosmerly and Bob Clement will serve as Trustee representatives on the SEAC. Trustees Judy Hunda and Dena Morrison will serve as alternates. Trustees will now be submitting biannual updates to report the activities of the committees on which they serve.

A recent audit indicated a budget surplus for the Board to be reinvested.

The Board passed a motion to renovate the former Wembley PS building and relocate all Board-level staff and services as well as the Restart and O'Connor

Park programs into the one location. The existing Board Office will be offered for sale following the move to offset the costs of renovation. The Ministry does not provide new funding to replace school board administrative buildings.

13.0 Chairperson's Report

The LDAS received a 3-year Trillium grant from the province in the amount of \$600 000 to expand their services into North Bay, Sault Ste. Marie, and Timmins.

14.0 Information Sharing and Success Stories

Autism Ontario (Natasha Delaney)

The vestibule at Jean Hanson PS is now complete. City bylaws and property ownership prevented it from being longer. The IBI worker who has been working with Natasha's son has agreed to work with school staff to orient themselves about her son's routines and use of Proloquo2Go. D. Squarzolo will distribute information about the local ADHD Parent Support Group.
