**1. WELCOME AND OPENING**

Host Anna-Marie Abitong welcomed everyone. Trustee Fox did opening. The Girls Drumming Group performed a welcome song and a special Valentine's love song.

**2. REVIEW AND APPROVAL OF MINUTES FROM NOVEMBER 12, 2015 MEETING**

Trustee Fox confirmed that the letter requesting full time principal for FNMI was sent to the Director of Education and also to Diane Cayen-Arnold for Budget Proposal.

Discussion ensued regarding Aboriginal Support Workers. Superintendent Dye and Kathy Dokis will be conducting interviews on March 9<sup>th</sup> 2016 to fill 2 full-time Aboriginal Support Worker permanent positions.

When hired, Superintendent Dye will call communities with contact information for the new workers.

**ACTION:** Attach job description for Aboriginal Support Worker to minutes.



Superintendent Dye reiterated that first and foremost they are to support students. Their secondary role is educating the staff to help build their understanding of First Nation culture.

Challenges that arise filling these positions occur due to temporary employment vs. permanent employment. Funding is year to year, therefore permanency cannot be guaranteed. Currently there are 12 Aboriginal Support Workers, 11 identify as FNMI.

General discussion occurred regarding Native Language teachers:

- Difficulty filling positions
- Incorporation of drama, dance and arts into their teachings
- How are strategies of teaching the language working? What measures are being taken to ensure this?

Kathy Dokis will be meeting with students at Manitoulin Secondary School and Espanola High School to get feedback from the students regarding their attendance. Superintendent Dye and Kathy Dokis will also meet with communities.

Kelly-Lee Assinewe motioned to accept minutes. Robert Pitfield seconded. Motion carried.

### **3. ELECTION OF CHAIR AND VICE-CHAIR**

Superintendent Dye announced calling for nominations for Chair. Kelly-Lee Assinewe was nominated by Anna-Marie Abitong. Seconded by Trustee Fox. Accepted by Kelly-Lee Assinewe. No other nominations were brought forward. Nominations closed.

Chair Assinewe called for nominations for Vice Chair.

Beverly Roy-Carter nominated Anna-Marie Abitong. Anna-Marie Abitong declined.

Carlene Assinewe nominated Nancy Cada. Nancy Cada declined.

Anna-Marie Abitong nominated Grace Fox. Seconded by Robert Pitfield. Grace Fox accepts on basis as a trustee of RDSB to support FNAC.

No other nominations were brought forward. Nominations closed.

Kelly-Lee Assinewe is the new Chair and Grace Fox is the Vice Chair.

### **4. NATIVE LANGUAGE AND NATIVE STUDIES COURSES IN RAINBOW SCHOOLS**

Superintendent Dye reviewed Native Language and Native Studies courses in our schools. All students are welcome to take any Native Studies course. No courses are mandatory yet, although it is strongly encouraged to take NBE as the Grade 11 English.

Courses are based on Ministry curriculum. Sharla Peltier, FNMI Learning and Teaching Cultural Specialist, and Kathy Dokis work together for suggested resources.

Question brought forward by Beverly Roy-Carter regarding Native Immersion. Superintendent Dye explained an immersion program is not planned for the near future. RDSB has a reverse agreement with KTEI for the immersion program. Currently there are 3 students in that program.

Anna-Marie Abitong explained that they have tried immersion in the past and problems arose due to not having enough language teachers to teach the program.

KTEI is currently the only First Nation that offers immersion. They are currently in their 3<sup>rd</sup> year of the immersion program.

Superintendent Dye reviewed second semester courses being offered.

ACTION: Bring updated list of courses being offered to the May meeting.

Superintendent Dye reviewed FNMI Enrolment. Chair Assinewe asked where does Mishko-Deh-Wendam's enrolment fall?

Action – Add enrolment for Mishko-Deh-Wendam.

Superintendent Dye discussed the importance of self-identifying at schools.

## 5. SHKI-NESEWIN PROGRAM

Superintendent Dye shared this new pilot program in partnership with KTEI. This is a new program which officially starts on February 29, 2016. Students will be off-site this semester only. The intent is to have program running at Manitoulin Secondary School in September.

1 Grade and 1 students enrolled from MSS. They will receive 4.5 credits for the semester.

RDSB provides a teacher and KTEI provides a teacher. RDSB is covering costs of program to KTEI.

Brenda Francis further explained the program. It is new to KTEI as well. Moving forward, some things to consider:

- How will the program be implemented in the Provincial system?
- There are many internal and external factors. It is an integrated approach with a teacher, a language teacher, a tutor and an elder. One teacher will not be good for this type of program.
- Need to ensure that staff shares the same philosophy.

KTEI started this program in September. They have a 100% retention rate and their students will receive 5 credits. These are interdisciplinary credits.

This brought forward a general discussion of the number of First Nation students going into alternative ways of learning. Some points discussed:

- Is the curriculum uniform between these alternative styles of learning?
- If students are not prepared to go to secondary school – what is going wrong before that point?
- How will students re-engage once back in 'regular' programming?
- How do all parties evolve? Parents, teachers, school and students?

Brenda Francis discussed that the new program is not an 'alternative' program. It is a different way of delivery. They are trying to get away from the 'alternative' label.

One way to look at these programs is holistic student development. These programs are culture-based education vs. provincial education system. Some will succeed in these programs, and some won't.

Superintendent Dye and Kathy Dokis introduced the data in the Annual Report.

Trustee Fox asked from the data presented, what is the average population of students that are enrolled in alternative programs? And how many are in provincial system?

ACTION – Bring back these numbers in May at the secondary level.

**Important note** - Mishko-Deh-Wendam is not represented in the Annual Report.

Questions brought forward regarding report for the 2014-2015 Annual Report:

- Consider changing format to represent each section of the Annual Report in terms of Seven Social Factors.
- Can there be a break down for Native Studies pass rate data?
- Can there be further explanation in the report as to why some of the trends are happening?
- Can the Special Education data be represented for the past 5 years?
- Can the summary be made more comprehensive to outline all aspects through the Annual Report?

The Board is looking to hire a Program Leader to support IEP improvements in schools.

Northeastern Elementary School hosted an Annual Awareness Day about learning differences with breakout sessions with various agency representatives.

Steve Marko and Sue Del Riccio gave a presentation on the A4 electronic tool at the recent Ontario Association for Developmental Education conference.

The Board sent 10 elementary and secondary teachers to the ASET Conference. The Board will be purchasing Google Read and Write licenses for every student between Grades 3 and 12.

At the May 25, 2016 meeting of Rainbow District School Board, Trustees unanimously passed the following motion:

*Motion: 16-R83, J.Hunda/B.Clement*

*That Rainbow District School Board endorse the Canadian School Boards Association's support of BILL C-241, An Act to amend the Excise Tax Act (school authorities) - **carried***

If approved, school boards across Canada would receive a full rebate on the Goods and Services Tax (GST). The rebate is currently capped at 68 per cent.

By charging the GST on school board purchases, the federal government is, in effect, adding a layer of taxation. This form of double taxation costs school boards millions of dollars annually. More importantly, it takes money away from the classroom and the students that we serve.

Rainbow District School Board continuously strives to innovate and to streamline in order to achieve efficiencies in the face of increasingly limited resources. Not only does the GST further erode our financial base, it also imposes a complicated and expensive administrative burden.

The current system of rebates, claims, and payments is onerous, and, in an effort to stretch our budget for the benefit of students, school boards feel compelled to engage expertise to help obtain the largest rebates possible while complying with regulations. The federal government recognizes the complexities of the current system. It has offered school boards courses on how to comply.

With this request, we are not asking the federal government to send new money to school boards. We are, however, asking the federal government to stop clawing back the support for education provided through provincial grants and federal transfer payments.

It makes no sense for school boards, as publicly funded – *taxpayer funded* - institutions, to take money away from student success to pay the GST. We are, in essence, transferring money from one level of government to another at the expense of students.

Rainbow District School Board, like other school boards across the country, wants to maintain the high quality of public education that Canada is renowned for around the world. We believe that it is the intent of the federal government to support school boards in their pursuit of excellence.

As such, we call on the federal government to ensure that school boards across Canada maximize the revenues that provincial taxpayers provide for public education.

On behalf of Rainbow District School Board, I urge you to support BILL C-241, An Act to amend the Excise Tax Act (school authorities) and look forward to your timely response.

### TRUSTEES OF THE RAINBOW DISTRICT SCHOOL BOARD

The success of the Ontario Public School Boards' Association (OPSBA) is strengthened by the commitment of our members to publicly funded education. We appreciate this opportunity to share with you the benefits of OPSBA membership and show highlights of our success this past year.

We invest our expertise and energy in ways that we know will have positive impacts on a wide variety of student needs across the province. Our voices are always rooted in our five priorities:

- *The Whole Child and Student Well-Being*
- *New Generation Education*
- *Trustees – Building Leadership Capacity*
- *Education Funding*
- *Labour Relations*

Throughout the past year, we have seen success on a number of our key action items, which include:

- The past school year saw an unprecedented Labour Relations role for the association as OPSBA successfully concluded and ratified seven central collective agreements for the first time as designated employer bargaining agent under the *School Boards Collective Bargaining Act (SBCBA)*. Agreements were reached with CUPE, ETFO Teachers, ETFO Education Workers, the Education Workers' Alliance of Ontario, the Ontario Council of Education Workers, OSSTF Teachers and OSSTF Education Workers. Since January 2016, OPSBA has also been involved in a comprehensive consultation process to review the SBCBA.
- The provincial government's legislative agenda has engaged OPSBA in a wide range of [advocacy work](#), including responses to Bill 181, the *Municipal Elections Modernization Act*, Bill 113, *Police Record Checks Reform Act*, and amendments to Regulation 444/98 (Disposition of Surplus Real Property).
- OPSBA was the founding member of the Ontario Coalition for Children and Youth Mental Health. The Coalition's profile continues to grow and its ability to provide timely expert advice on issues is well-recognized. In April 2016, the Coalition held a successful fourth Summit on Children and Youth Mental Health in Toronto, attracting more than 700 attendees. The next Summit will be held on April 12 and 13, 2018.
- OPSBA's First Nation Trustees Council provides a strong voice in advocating for First Nation, Métis and Inuit Education. The Council has engaged in a range of initiatives this year, with a primary focus on mandatory components in Ontario's elementary and secondary curriculum on FNMI histories that includes treaty education, the history and legacy of residential schools, and the impact of the *Indian Act*.
- Our five new and 14 updated [Professional Development Modules](#) were available in time for the beginning of the 2015-16 school year. Inspired by the thoughtfulness and commitment that trustees bring to their governance work, the modules include: What Makes a Great Board Chair?; First Nation, Métis and Inuit Education for school board trustees; Code of Conduct for Trustees; Social Media; and Internal Audit Committees.

- In early May, OPSBA President Michael Barrett spoke to media regarding the importance of autism intervention programs for children over the age of five after the government announced changes to eligibility for Intensive Behavioural Intervention (IBI), IBI wait lists and the automatic transition from IBI to Applied Behaviour Analysis (ABA) at age five. "We're hoping the government will give careful reconsideration to changes being made," President Barrett told [the Toronto Star](#). "It's never too late to correct a mistake." He also called on the government to show "the same courageous leadership" it demonstrated in April when it changed plans to close provincial schools for deaf students and those with severe learning disabilities.

In addition to the accomplishments noted above, our advocacy for student success and the governance role of school board trustees has extended well beyond the borders of Ontario. OPSBA responded with [strong public support](#) of the Quebec English School Boards Association in their fight against that province's Bill 86, which would have amended Quebec's Education Act to replace commissioners (trustees) with school councils. This spring, the government abandoned the legislation. We stand proudly alongside our colleagues in Quebec in defending the role of trustees, the only democratically elected position solely responsible for providing sound educational opportunities for all students.

More recently, OPSBA has emerged as a key signatory to a Canadian School Boards Association [letter](#) to Prime Minister Justin Trudeau supporting a private member's bill, Bill C-241 – *An Act to amend the Excise Tax Act (school authorities)*. This proposed bill would amend the *Excise Tax Act* so as to increase the goods and services tax rebate rate for school authorities/boards from 68% to 100%, resulting in millions of dollars in savings for our member boards. We continue to advocate in support of Bill C-241 through all available channels and are promoting the [public petition on our website](#).

**Our programs and services are highly cost effective.** The financial benefits of membership far exceed not only the membership fee itself, but the outcomes that could be achieved by boards acting individually. Our interventions on copyright tariffs, natural gas rates and electricity rates have continued to create significant savings for all school boards and cover membership fees many times over. When this is combined with the indirect benefits created by OPSBA coordination and advocacy identified in this correspondence and our [Key Work](#) document, the value of membership speaks for itself.
