6. **Director's Remarks**

1. Technology and Learning Fund:

As you are aware, in September 2014, Minister Sandals announced the Ministry's commitment to invest in a new \$150M Technology and Learning Fund (TLF) over three years as part of moving towards 21st century teaching and learning as a key goal of Ontario's renewed vision for education, Achieving Excellence. The TLF has a number of components, including two funding allocation components to support transformation efforts underway in district school boards that build on the foundations of investments to date through the 21st Century Innovation Research Initiative.

This month the ministry has served notice that boards may initiate plans to trigger the work.

Rainbow DSB has combined allocation of \$312,346.95 for 2014/2015.

Two components include:

- 1. The TLF Enhanced Supports \$223,346.95 with a focus on purchasing equipment 80% allocation (IPod's, tablets etc...) and a 20% allocation on some PD.
- 2. TLF 21st Century Innovation Research Initiative -\$89,000.00 Focused support will be provided to undertake research aimed at documenting local theories of action, impact evidence, progress toward systematizing and scaling-up effective teaching and learning innovation practices, and promoting knowledge obilization and capacity building for innovative technology-enabled teaching and learning and system change. This will contribute to the evidence and research se informing system learning and local decision-making about effective 21st cent teaching and learning practices, including support for student acquisition of impant higher order 21st century competencies.

We expect that the TLF initiative will be continue or the new your ears the Ministry making board specific allocation announcements in the fall of 201/ and 20.03.

2. Community safety and Well Being Planning in Green's Sudbar

As part of a Proceeds of Crime Grant provided by the Minica of Community Safety and Correctional Services, the City of Greater Surbuchas been acted as one of ten communities across Ontario to participate in a collaborative, multi-agency project that will result in the development of in integrat of Community Safety and Well-being Plan, resulting in a safer, healthic mmunity for eryone.

The committee in oduced the project and sought commitment to participate. Planning sions and working sub-committees were expected to evolve over a 12 to 18 from line.
- On February 2nd the Project Steering Committee will be inviting stakeholders, those individuals that are assigned the task, from partner agencies to attend a facilitated planning session. During this session participants will identify and prioritize the key risks for our community and start the process of building the Safety and Well-being Plan. Further planning sessions will be scheduled.

3. Partners for Children and Youth (PCY)

Community Mental Health Plan was shared by the lead agency Child and Family Center (CFC). Focus on 2014/2015:

Community engagement

- Current Service Provision and Pathway to Care
- Local child and youth health Community planning mechanisms

Next steps – CFC to contact our Mental Health Lead to review the three areas identified and gather information on our protocols/pathways as well identify resources we access etc...
