When these above mentioned police or social services enter our facilities for the purposes of career days, classroom presentations and for the purposes of planning strategies at management/supervisory level, verbal invitation at the discretion of the principal or designee will suffice and the above statement will apply.

- 1(a) Any and all agencies that enter RDSB for purposes of enforcement or investigation and request to interview staff or students shall be permitted to do so only under the following circumstances.
 - i. With express written permission and knowledge of a parent or guardian
 - ii. With personal possession of a court order, be they an agency acting as the court appointed guardian or otherwise.
 - lii As permitted by law in an emergency intervention, (Child Law Reform Act., R.S.O. Ontario) and when time does not allow the requestor to obtain a court order, one must be obtained by the requestor and provided to the RDSB from whence the child was removed/interviewed or otherwise interviewed, within the prescribed times as required in law
 - (iv) As provided for in the Education Act R.S.O. Ontario, only with the written permission of the Principal or designee acting in the stead of the parent or guardian.
 - (v) Under no circumstances shall a student be left unattended and alone with a police officer or social service agency representative within the confines of a school facility without a witness/employee of RDSB as designated by the Principal when the parent guardian of the child is not readily available. (Section 2 of CFSA)
 - (vi) In compliance with our (RDSB) commitment and solemn promise to first nations, any first nations student who finds themselves drawing attention by the police or social service agencies, the Principal or designee will immediately activate a notification to child and family services or police in the respective home reserve of the student. No exceptions. **Defeated**
