Meeting to decide accommodation review outcomes rescheduled

The Special Meeting of Rainbow District School Board to decide accommodation review outcomes has been rescheduled to Tuesday, February 7, 2017.

"At public meetings, parents asked the Board to delay the decision date until secondary school exams were complete," said Chair Doreen Dewar. "Trustees passed a motion approving the new date at the regular Board meeting held on October 25, 2016."

Rainbow District School Board is carrying out accommodation reviews in six planning areas in the 2016-2017 school year - Central Sudbury, Espanola, New Sudbury, Valley East, Valley North and West Sudbury.

The Board is currently seeking input at a series of public meetings. The input will inform the Capital and Accommodation Plan Final Staff Report.

The Board will continue to receive input through its online feedback form until Wednesday, November 16, 2016.
