# 2. Sudbury Secondary School Renewal Advisory Committee

Superintendent Law introduced the committee members, trustees and members of the Administrative Council.

#### 3. Mandate and Timelines

Superintendent Law provided background information regarding the committee's mandate. At the January 29, 2007 Board Accommodation Review meeting, trustees approved that a community consultation occur for the renewal of Sudbury Secondary School.

## 4. Sharing the Data

Superintendent Law introduced Diane Cayen-Arnold, Superintendent of Business. She reviewed the state of Sudbury Secondary School and the utilization of Ministry benchmarks for funding. She also reviewed the data with regards to enrolment, space, FCI (facility condition index) and costs. This presentation is available online at rainbowschools.ca. Superintendent Cayen-Arnold stated that this was the first public meeting to explain how the renewal of Sudbury Secondary School would take place.
