3. Mandate and Timelines

Diane Cayen-Arnold indicated to the audience that the firm Castellan James & Partners was hired to give advice as to which part of the school should be maintained before the final plan is in place. The committee has to formulate its recommendations and has to come back to the committee before the final recommendations are presented to Admin. Council and the Board. Diane Cayen-Arnold also informed the audience that when the recommendations are presented to the Board, anyone wishing to attend that meeting are more than welcome to attend. Superintendent Law mentioned that the Advisory Committee will review the recommendations in November. The Admin. Council will forward the recommendations to Trustees in December and in February 2008 the Board will make its final decision.
