To ensure that all students continue to have access to the best programming possible in quality school facilities.




PRIORITIES IN OPTION DECISION-MAKING

- Only JK to 8 English school with 3 system classes (Primary Autism Spectrum Disorder (ASD), Junior ASD, Comprehensive) in the area
- Exceptional model of public education/social inclusion due to diverse student population and programming
- Variety of school programs generates student interest in academics and promotes participation



PRIORITIES IN OPTION DECISION-MAKING

- Children and families live and go to school in the same community
- Before and After school program
- Integrated recreational site for diverse local activities
- Accessible to attractions within walking distance
- Wembley PS supports local residential renewal and stability
- Landmark in community





STATUS QUO

STRENGTHS

Landmark and building still exist

- Building will continue to deteriorate, no preventative mode
- Facility Condition Index (FCI) will rise from 87% to a higher percentage
- Potential future safety issues
- Reduction in local community use



REQUEST PROHIBITIVE TO REPAIR (PTR) MONEY FROM MINISTRY

STRENGTHS

Better than status quo

- Not best use of resources
- Same building but no significant renovations
- No guarantee of receiving funds or how much

PROGRAM CHANGE



STRENGTHS

- Moving a group of students still leaves students in a PTR school
- The school becomes underutilized
- JK-8 program or the social inclusion not maintained
- Splits families



CLOSE SCHOOL BOUNDARY CHANGE: Reassign students to neighbouring schools

STRENGTHS

Removes Facility
 Condition Index (FCI)
 problem

- School community would be divided
- Addition/renovation to Adamsdale, Lansdowne, MacLeod and Princess Anne Public Schools
- Increase bussing routes
- No guarantee that funds will be available



CLOSE SCHOOL ALTERNATE SITE: ST. DENIS

STRENGTHS

Capacity is 403

- Building is PTR
- Gym is small
- Bus lay by is a safety concern
- Noise levels from Regent Street affect classes



BUILD A NEW GREEN SCHOOL ON SITE

STRENGTHS

 Will address all the priorities

WEAKNESSES

Ministry will not fund



ADDITION TO PRINCESS ANNE PS TO ACCOMMODATE WEMBLEY PS STUDENTS

STRENGTHS

- Consolidate two schools on one site
- Part of catchment area for Wembley PS, Princess Anne's grade 6 students feed into Wembley PS
- Supports students and families attending local school
- Supports renewal in area


- Loss of walking access to facilities (e.g.: Science North)
- Former walkers may require transportation
- Some adjustments to boundary perimeter
- No guarantee of Ministry funding

Addition to Princess Anne (cont'd)



STRENGTHS

- Maintain the social inclusion, Princess Anne has specialized programs
- Enhance JK-6 to JK-8 program
- Recreational focus maintained
- Princess Anne has property to expand
- Optimum use of resources by combining Wembley's PTR money, sale of the school and Princess Anne's Primary Class Size (PCS) capital





- STRENGTHS
- JK-6 will still be part of the catchment area
- Supports renewal in area
- Larger cohort of intermediate students
- Receiving schools can accommodate

- WEAKNESSES
- Split families
- Loss of walking access
