2. Governance By-Law 14: Electronic Meetings

That *Governance By-Law 14: Electronic Meetings* be amended as follows:

“**14.8 Board members who participate in In-Camera meetings of the Board and/or in-camera meetings of committees of the Board shall maintain rules of confidentiality and are subject to Governance By-Law 10.2 and Board Policy No. GOV-05 Code of Conduct: Board Members**” be recommended to the Board as a Notice of Motion. - **Carried**

b) Motion: G.Santala/B.Clement

That *Governance By-Law 14: Electronic Meetings* be amended as follows:

“**14.9 Board members who participate in in-camera meetings by electronic means, must participate from a room which is closed to any other person so that no other person can hear that member or other members of the Board**” be recommended to the Board as a Notice of Motion. - **Carried**

c) Motion: D.Dewar/T.Campbell

That *Governance By-Law 14: Electronic Meetings* be amended as follows:

“14.10 With the exception of the boardroom, speaker phones, cell phones, or portable phones or web video-conferencing ~~may~~ shall not be used during any in-camera meetings of the Board” be recommended to the Board as a Notice of Motion.

Trustees discussed the security of in-camera meetings and decided not to vote on 14.10 indicating their preference to end participation in in-camera meetings via phone. A new motion will be presented for consideration at an upcoming Strategic Planning Committee meeting.
