4. Director's Remarks

Director Blaseg reported on the OSSLT Results. Nearly 700 Rainbow students passed the Ontario Secondary Literacy Test that was held last fall. As you might recall this was the first attempt at an on-line version of the assessment. Throughout the morning, on the day of the test, students and staff had to

overcome many challenges related to the electronic version. As a result hundreds of students were unable to verify if their efforts were compromised by challenges associated with the delivery of the test. EQAO did release possible rationale that could explain what happened to students who made an attempt but were unsuccessful.

As reported by EQAO

Include students who:

- Logged in but were unable to start the test
- Logged in but for whom EQAO did not receive sufficient work to provide a result: and
- Logged in and for whom EQAO received sufficient work to allow for a result but who were not successful (This outcome could have been affected by the technical issues experienced on the day of the test, so it may not accurately reflect the students ability.)

The 700 plus students that did not have a positive outcome/experience will have a second opportunity to attempt the test (paper version) in spring 2017. Finally we want to impress upon everyone that it is a tribute to staff and students that so many students persevered and were successful in spite of all the challenges the day presented. As a result 671 students were successful in attaining their OSSLT requirement. We are thrilled these students will be recognized for their efforts. A special thanks to the Trustees for lending their voice in supporting efforts to ensure student assessments that did go forward were counted.

The Director reminded trustees of the upcoming Professional Activity day on Friday, February 3rd. Elementary teachers will be focused on Assessment and Evaluation and secondary teachers will be completing first semester grade placements and prepping for second semester. Support staff will continue to participate in certifications (ie: B.M.S. training) and other related professional growth activities.

Monday, February 6 is the first day of the second semester. Director Blaseg reminded trustees of the recent appointments of Jamie Mohammed as principal of Manitoulin Secondary School and Margaret Stringer as interim principal at Little Current Public School starting the first day of semester two.

She provided trustees with information about guest speakers and the sessions that she attended. 7. Chairperson's Remarks

Congratulations to our very own Student Trustee Katie Yao on having been chosen as one of only 84 finalists nationwide for the Loran Award. To have been shortlisted from 4400 applicants is an honour in and of itself. Katie, trustees and staff have known for some time what a truly outstanding young person you are. We are so very proud of you and we are extremely grateful to have you at our Board table to advocate for our students. Good luck.

I was privileged to attend the 2017 Public Education Symposium organized by OPSBA. I never fully appreciate the benefits of this opportunity until I get there. It was very informative and inspiring.

At the first LEGO League Regional Qualifier held in December 2016, the R. L. Beattie Baron Bots garnered first place overall for their robot and the highest overall score in the Project, Robot and Core Values categories. The Baron Bots will compete at the Provincial Championship in Waterloo this coming Saturday (February 4, 2017).

Students in Rainbow Schools collected 5,500 gently used winter clothing items for local families in need. The drive, spearheaded by Cooper Equipment Rental, helped to support Our Children, Our Future and include coats, snowsuits, boots and other accessory items.

Rainbow Schools collected 257,942 items for Edgar Burton Kids Helping Kids Food Drive. For the second year in a row, they topped the quarter million mark! A total of \$30,515 in monetary donations contributed to this impressive total.

Kindergarten Information Nights and Secondary School Information Nights continue to be held. The public is invited to check the Board website or contact specific schools for more information.
