C. PRESENTATION

1. Students as Researchers (StAR)

Superintendent Noble introduced Student Trustee Madeleine Leach Jarrett and Student Senators Shanelle Tremblay, Michaela Bouffard and Josh Tilston. The students shared a presentation with trustees that they presented on April 17, 2018 at a Ministry event in Toronto.

The presentation, Stand Up on Youth Mental Health, was created by student senators who surveyed their peers about well-being. The students explored sleep, nutrition, exercise, time spent outdoors, academic related stress and post-secondary transition stress. The group looked at ways to support students. Survey results were shared and discussed and future steps were provided, for new student senates to work toward in the future.

Trustees shared their appreciation of the commitment to student well-being.

2. Instructional Strategies to Support Vocabulary Development

Superintendent Noble introduced Sherry Conroy, Principal of Program, to present to trustees about *Instructional Strategies to Support Vocabulary Development*.

Sherry Conroy explained what is required from teachers in order to see growth in vocabulary. She informed trustees about wide reading, dictionary use and direct instruction and explained concept mapping, semantic mapping, teaching word parts, prefixes, suffices, roots words, word parts, comparing and contrasting and dialog reading.
