Mandate	To ensure Rainbow students are successful in a variety of summer programs.			
Background	Rainbow District School Board offers programs during the summer months to support students.			
Information	Elementary Special Education: For the past eleven years, Rainbow District School Board has offered the Summer Program for Students with Autism Spectrum Disorder and the Summer Social Emotional Program. These programs service students from ages 4 to 12. A total of 20 students participated in these programs at Princess Anne Public School, Jean Hanson Public School and Redwood Acres Public School.			
	Indigenous Summer School: Indigenous summer school continued for the second year during the last 2 weeks of August at Manitoulin Secondary School and Espanola High School. The Careers and Civics Course has been adapted to include stronger Indigenous content. Students attended full days for 2 straight weeks plus a weekend cultural camp hosted by Sheguiandah First Nation with a trades focus. Students had many opportunities to learn from Elders and other local guest speakers, visit First Nation communities and explore trades programs at Cambrian College. An opportunity to be inspired by Niigaan Sinclair during their visit to the RDSB Centre for Education was also a highlight for the students.			
	Kindergarten Camp: This nine-day program, which runs for the last 2 weeks of August, was offered three hours a day at a number of Rainbow Schools. Under the guidance of 19 qualified teachers and 9 designated early childhood educators, approximately 200 children engaged in inquiry based learning and play, including co-operative games and outdoor activities. This year, Kindergarten Camp was hosted at A.B. Ellis Public School, Adamsdale Public School, Alexander Public School, Algonquin Road Public School, Assiginack Public School, C.R. Judd Public School, Chelmsford Public School, Lansdowne Public School, Larchwood Public School, Little Current Public School, Markstay Public School, Northeastern Elementary School, Princess Anne Public School, Queen Elizabeth II Public School, Redwood Acres Public School and S.Geiger Public School.			
	Elementary: For the eighth summer, Rainbow District School Board offered Summer Programs organized by Council of Ontario Directors of Education (CODE) and funded by the Literacy and Numeracy Secretariat (LNS). The focus was to support students who are currently achieving below the provincial standard and to minimize summer learning loss. There were ten classes across four sites that served 161 students. The program			





was hosted at Cyril Varney Public School, Chelmsford Public School, Lansdowne Public School and Little Current Public School. Each class was supported by secondary or post-secondary students funded through the Ontario Focused Intervention Partnership (OFIP) and the Ministry of Education. Enhanced funding was also provided to support robotics, coding and STEAM activities. The principal was Daniel Koziar. Elementary (Grades 6 – 8): For a second year, Rainbow District School Board offered an Intermediate Summer Program modelled after the Primary / Junior Summer Learning Program. Program goals included minimizing summer learning loss, supporting students who are currently achieving below the provincial standard and the promotion of fundamental literacy and numeracy skills in a fun and engaging atmosphere. The grade 6 program focused on numeracy, while the grade 7/8 program had both language and mathematics components. Fifteen grade 6 students and seventeen grade 7 and 8 students participated in the program at Princess Anne Public School. Three experienced teachers, supported by university students and a consultant as site lead, maximized small group learning opportunities and afforded students a wealth of one-on-one support. Dave St. Amour was the principal of the Rainbow Intermediate Summer Learning Program. Mind Over Metal Summer Camp For the first time, Rainbow District School Board offered a Mind Over Metal Summer Camp at Lively District Secondary School. This five day camp was funded primarily by the CWB Welding Foundation and was one of 70 camps offered nationwide. Program goals included engaging at-risk youth in the welding trade. Eighteen Rainbow students ranging from Grades 6 - 9 were participants in the camp. Participants were provided with breakfast and lunch every day of the camp as well as instruction and hands on opportunities to build projects using welding tools. The camp also had three Rainbow staff involved, three current RDSB secondary students (Grade 10), one recent RDSB secondary school graduate and three post-secondary students currently in the Welding Fabricator Program at Cambrian assisting the camp participants at a two-to-one ratio. Mr. Dinnes was the site leader for this camp. Secondary: Secondary programs continued this past summer included eLearning Summer School, the Ontario Secondary School Literacy Course, 3 Credit Co-operative Education and Credit Recovery. Programs were located at Sudbury Secondary School (Adult Ed Site) and Barrydowne College. New programs this summer included a one week program for 18 students in grades 6/7/8/9 that ran in the Welding shop at Lively District High School and focused on Literacy and Numeracy in the context of practical welding projects.

9. Chairperson's Remarks

I am reminded of another Ontario government who attacked the education system after first acknowledging the need to "create a crisis".

I am concerned that this provincial government wants us to believe that the crisis in education has to do with the sex ed curriculum.

Education Minister, Lisa Thompson is quoted as saying "Our end goal across all of these activities is simple: create an education system that respects parents while preparing our students for success."

How do you prepare students for success without respecting their teachers and indeed, all educators?

How do you prepare students for success by setting up snitch lines and removing funding for Special Education?

With the deepest respect, I would like to request that MPP Mantha, MPP Gelinas and our newest MPP Jamie West help the students of the Rainbow District School Board and right across the province. I challenge you to stand up on the floor of the legislature and demand the return of funding for our most vulnerable young people. Students in your constituencies will be negatively impacted with the loss of approximately 1.3 million dollars. The thought for the month comes from Abraham Lincoln Who said, "I am a firm believer in the people. If given the truth, they can be depended upon to meet any national crisis. The great point is to bring them the real facts."

Notes to Financial Statements

Year ended August 31, 2016

Nature of operations:

Ontario Student Trustees' Association (the "Association") is a not-for-profit organization under the provisions of the Education Act. The Association is the largest stakeholder in education and is the voice for the student vision.

1. Significant accounting policies:

These financial statements are prepared in accordance with Canadian accounting standards for not-for-profit organizations. The Association's significant accounting policies are as follows:

(a) Basis of presentation:

These financial statements were prepared using the accrual basis of accounting. Revenues are recognized as they become available and measurable. Expenses are recognized as they are incurred as a result of receipt of goods and services and the creation of a legal obligation to pay.

(b) Revenue recognition:

The Association uses the deferral method of accounting for contributions which include board membership fees and registration fees. Externally restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Revenue from fees is recognized when the service is provided.

(c) Capital assets:

Capital assets are recorded at cost. Amortization is provided on a straight-line basis over the estimated useful lives as follows:

2. APPROVAL OF AGENDA

3. REVIEW AND APPROVE MINUTES FROM FEBRUARY 15, 2018

4. BUSINESS ARISING

5. SUCCESS STOR.

Principal Dokis manual the role of the new Cultural Liaison for Indigenous Education (K-12) position and how appreciative schools have been to be able to access the expertise of this position.

Blanket Exercise was included as part of the new curriculum professional learning roll out and teachers found it extremely powerful and moving. Many have been engaging in providing the learning opportunity for their students.

Indigenous Collaborative Inquiries continue to support teachers working with Indigenous community partners and/or resource people and families to help our staff learn more about Indigenous ways of knowing in order to better support Indigenous students. It has been a good way to help foster deeper relationships with our schools and Indigenous community partners.

A class at Manitoulin Secondary has been working in collaboration with Sheguiandah First Nation on a pilot Memoires project as per the Truth and Reconciliation: Commitment to Action. The project will be broadened over the next few years to capture stories and histories of all local First Nation Communities.

There was much group discussion in regards to the importance of moving forward and Trustee Dewar stated that it is so much better when the ideas come from FNAC and not from us. Robert Beaudin expressed appreciation for what RDSB is doing and how the board is so much further ahead of other boards. He reminded the group that when these thing scan be done in the language, then we have success. Cynthia and Kim highlighted the importance of coming to the communities and schools have been taking good efforts to do this.

6. INDIGENOUS EDUCATION ADVISORY COMMIT

Principal Dokis provided an update a we have been hearing a lot about IEACs. Principal Dokis spoke with the Director of the Indigenous Education Office. The Director indicated the a task from continues to work on what currently exists around the province. They want to be sure what they put forward in terms of potential legislation does not undo the good work many Boards have already been doing. The Ministry is considering how you bring people togenier apprecriate. For example keeping the needs of the First Nation communities distinct and not part of the business of other Indigenous organizations or groups. May possibly have something by spring 2019 or the fall of 2020.

Trustee Fox shared that she has been attending meetings about IEACs. She expressed concern that it is always about an advisory role. She would like to see more involvement in school board education and action plans. She questions what role the AES will play, do they have a voice or does each AES community have a voice. Kim mentioned that the AES does not speak for First Nations and that the authority still lies within the First Nation.

7. TRC ACTION PLAN UPDATE

Principal Dokis shared that the Draft TRC Action Plan was first presented to Strategic Planning Committee in April. We hope to bring it to a Board meeting for approval before the end of the year with full implementation for Fall 2018.

Trustee Clement shared from OPSBA perspective that we are so far ahead of many boards in many areas, including Indigenous. Trustee Fox indicated that Rainbow is open and knowledgeable about Aboriginal issues.

8. STRENGTHENING OUR LEARNING JOURNEY: THIRD PROGRESS REPORT

Principal Dokis provided a copy of the executive summary. FNAC participated in this feedback session last May, 2017 in Sheshegwaning First Nation by teleconference with a researcher. Many Indigenous and non-Indigenous communities, families, students and community mentions bers provided feedback for this report. The full report can be found online.

10. CURRICULUM AND OTHER UPDATES

Principal Dokis highlighted how Indiaenous stoff and community partners worked to develop and/or deliver a top-day roofessional learning opportunity for the new corrigilus role-congrade 10 history teachers, Grade 7-8 history teachers and item social tudies teachers). The Ministry of Education continues to pork on the TRC Calls to Action # 62 and #63, which includes making any proprioritate curriculum on residential schools, Treaties, and Aboriginal peoples thistorical and contemporary contributions to Canada mandatory for K-12 students.

The draft versions of f e First Nations, Métis and Inuit Studies courses has been released (NAC 10, NAC 20, NBE 3U/3C/3E with an additional five to be released this summer (NDA3M, NBV3C/3E, NDG 4M, NDW 4M).

Discussion was had around the table about the importance of language and work to begin in June around kindergarten immersion curriculum. Cynthia Trudeau shared a model of language learning in their community this year and how it was connected and supported language learning at Little Current Public School. She suggested offering a year round course like this that could be for credit at the secondary level. Robert Beaudin reminded the group about the Anishnaabemowin revitalization project in their community and that there are free resources they would like feedback on.

11. SUMMER SCHOOL

Principal Dokis provided details about the Careers and Civics course that will once again be taking place at Espanola High School. The same two teachers from last year have been hired as well as 2 new ASWs for each site has been hired. The course is a transition support for Grade 8 students coming into grade 9. It will be open to Indigenous and non-Indigenous students. The weekend learning camp will be taking place in Sheguiandah First Nation on August 25-26 with a focus on culture and careers.

Robert Beaudin praised this initiative saying that students fit in and transitioned into secondary much easier.

12. New Business

Carlene expressed concern with the language program. Manitoulin since the original teacher has been off. Principal Dokis continues to work with the school and communities to find fluent speak. Is the used support the program until the teacher returns and to ensure the students meet with success.

At the regular meeting of Rainbow District School Board on August 28, 2018, trustees were dismayed to learn that substantial losses in special education funding will have a significant impact on our most vulnerable students.

This prompted trustees to approve the following motion: Motion: 18-R131, J.Hunda/D.Morrison That Rainbow District School Board write a letter to the Ministry of Education concerning the drastic cut in Special Education funding. - Carried

The redistribution of the Special Incident Portion (SIP) funding, coupled with changes to the Special Education Per Pupil Amount (SEPPA), will result in a net loss to students of \$1.3 million. We have an exceptional number of students with special needs. The loss in funding, therefore, will have a wide-spread negative impact across Rainbow Schools in Sudbury, Espanola and Manitoulin Island.

We are the largest school board in Northern Ontario. Many of our Special Education students are transferred to us from our coterminous boards. Additionally, where services are not readily available outside the classroom, Rainbow District School Board is often the sole resource for many families within our huge geographic area.

Our 2018-2019 budget was approved on July 3, 2018 based on what was considered reliable information from the Ministry. We are currently re-assessing the full impact of this provincial decision on our special education students, programs and services.

On behalf of the many affected families, Madam Minister, we urge you to please reconsider this redistribution. Our neediest, most vulnerable students deserve more, not less.

Re: 2018: B14 Update: Education Funding 2018-2019

At the Regular meeting of District School Board Ontario North East dated Sept. 4, 2018, the "Update: Education Funding for 2018-19 Memo" of August 24, 2018 was reviewed and discussed in depth. I have been directed by the Board of Trustees to respond.

Specifically, I am writing to express our concern that the compensation adjustments for Trustee honoraria will have a negative impact on the role of the Trustee. As a smaller Board, our Trustees' honoraria is already at the base amount and the decision not to honour the meager increase of \$400.00 as announced in 2018 B6 memo is seen as an unjust action.

The announced changes to eliminate the non-taxable portion (i.e. one-third of the trustee honorarium) by the Canada Revenue Agency Act, effective January 1, 2019, will have an additional impact on the honoraria. Our trustees feel that we are being attacked. Our honorarium is not only being frozen, it is being subjected to a serious reduction.

As advocates for public education and representatives of our constituents, our focus continues to be on ensuring our Board promotes the Mission, Vision and Priorities of our Strategic Plan. Our commitment and focus to provide safe, respectful and inclusive learning environments, where each student is empowered to achieve personal excellence, involves multi-tiered interactions between the Board, students, parents, and communities.

In summary, given the personal time and energies required of each trustee to attend to their duties, we request that the Honourable Minister review and rescind the suspension of the increase in the base amount of trustee honoraria.

The Ministry of Education introduced a "thorough provincewide consultation with parents to obtain input about their children's education" including "an online survey, telephone town halls and a submission platform that will allow interested individuals and groups to present detailed proposals to the Ministry" on August 22, 2018. The Ministry also launched "a dedicated submission platform — Fortheparents.ca — that parents can use to report any concerns".

"Vibrant communities and a prosperous society are built on the foundation of a strong education system" (Source: Ministry of Education, Who We Are found at <u>www.edu.gov.on.ca/eng/about/whoweare.html</u>). The HDSB Trustees agree that all students, the education system and indeed society would be well served by a "thorough province-wide" consultation that is inclusive of all stakeholders and their diverse opinions.

The Ministry's press release affirms that "Parents from across Ontario will finally have the opportunity to have their voices heard on the kind of curriculum their children are taught in school" and looks forward to a "robust discussion."

At the September 5, 2018 Board Meeting, Halton District School Board's Board of Trustees approved the following resolution:

Be it resolved that the Board of Trustees direct the Chair to write a letter to the Ministry of Education, copying the Ontario Public School Board Association and all Ontario Public School Board Chairs, to request that inclusion-related enhancements (such as inviting diverse comments from the full range of education stakeholders) be implemented for the on-line platform "fortheparents.ca" and carried forward to all aspects of the province-wide public consultation taking place regarding the Ontario Curriculum, and to offer support in this regard, as appropriate, and to request a response.
