TRUSTEE HONORARIA

- 1. The Board will determine the amount of annual allowances or honoraria to be paid to trustees in accordance with provincial legislation.
- 2. The honorarium for each of the nine trustees, excluding the student trustee, of the Rainbow District School Board will be calculated as follows:
 - a) <u>Base amount</u>: \$5,900.00; plus
 - b) <u>Enrolment amount</u>: Multiply the Average Daily Enrolment (ADE) from the previous school year by \$1.75. Divide that number by the number of elected trustees. This represents the maximum amount that each trustee who is not a chair or vice-chair may receive, excluding the attendance and distance amounts.
- 3. The additional honorarium for the Chair and Vice-Chair of the Board will be calculated as follows:
 - a) <u>Base amount</u>: \$5,000 chair, \$2,500 vice-chair; plus
 - b) Enrolment amount:
 - For the chair: ADE from the previous school year multiplied by \$0.05 with a minimum of \$500 and a maximum of \$5,000.
 - For the vice-chair: ADE from the previous school year multiplied by \$0.025, with a minimum of \$250 and a maximum of \$2,500.
- 4. Trustees will receive a distance amount of \$50 per meeting attended when the trustee travels more than 200 kilometers (one-way) from his or her residence to attend a meeting of the Board or its committees required to be established by an Act or a regulation made under an Act i.e.; Special Education Advisory Committee (SEAC), Supervised Alternative Learning Committee (SAL), Parent Involvement Committee (PIC), and Audit Committee.

Trustee Honoraria

- 5. In the event that a trustee is absent from all of the meetings in two successive months (i.e. Board and Committee meetings), the trustee will be deducted the amount of honorarium paid for that period.
- 6. The application of this section may be dispensed with by leave of the Board when a physician's certificate is submitted certifying the trustee's inability to attend the required meetings.


13. Poverty Working Committee Update

On behalf of the Toronto District School Board, I am writing you to express the importance of returning to Indigenous curriculum writing initiatives, immediately, as part of honouring the commitments made to the <u>Truth and Reconciliation</u> <u>Commission's</u> calls to action #62 and #63.

In July 2018, your government cancelled curriculum writing-sessions with Indigenous educators and elders that were years in the making. This important work would have led to students across the province learning about Indigenous perspectives, cultures and peoples, and the legacy of residential schools.

For many, this was seen as an unfortunate step back in redressing the legacy of residential schools and advancing the process of Canadian reconciliation.

We believe it's important that our students are exposed to, and embrace, the diverse peoples and communities that make up our schools, province and country – and we, as leaders in education, have a role to play to ensure these opportunities happen inside and outside of the classroom.

These writing sessions would have been the perfect opportunity to gather real, authentic information from our Indigenous community that would have benefited our students for years to come.


Our ask is that you reinstate the Indigenous curriculum writing initiatives that include the involvement of Indigenous peoples, educators and elders.

At the regular meeting of Rainbow District School Board on October 23, 2018, trustees expressed deep disappointment that Parents Reaching Out (PRO) Grants may be cancelled.

The following motion was approved:

Motion: 18-R131, J.Hunda/D.Morrison That RDSB write a letter to the ministry, with copies to MPPs, regarding the positive impact of the Parents Reaching Out (PRO) grants and the negative effects of any decision to discontinue. - Carried

PRO grants have a direct impact on student learning, whether focusing on math or mental health. Over the years, these grants have given our schools and our School Councils the opportunity to invite parents/guardians and the community to participate in hands-on activities. The attached news release provides a summary of grants received in the 2017-2018 school year.

In addition, PRO Regional grants allowed the Rainbow District School Board Parent Involvement Committee (PIC) to bring parents/guardians from all of our schools together. Just this past spring, PIC hosted a conference for parents by parents with a focus on mental health, equity and inclusion. In previous years, grants enabled us to produce literacy tip sheets, math tips sheets, a series of mental health brochures, information on growth mindset and resources for a board-wide transition evening. These resources remain on our website for all to access.

The Province of Ontario recently launched public consultations. The invitation for feedback tells us that you value parental input and want to actively engage all partners in education in the learning process. PRO grants engage at the grassroots level, the level closest to students. We urge you to continue to offer our School Councils and Parent Involvement Committee the opportunity to access these funds. They are a solid investment.

Rainbow Schools receive grants to enhance parent involvement
