C. **PRESENTATIONS**

Superintendent Noble introduced the third component in Rainbow District School Board's Strategic Directions, Literacy Comprehension. This component followed previous presentations on Automaticity/Spaced Practice in year 1 and Vocabulary in year 2.

Principals Lesley Fisher, Heather Gaffney and Colleen McDonald spoke about literacy comprehension, a balanced literacy program, shared reading, summary of EQAO results and a shared reading model using GRASS (Given, Required, Application, Solution, Summary).

Teachers Dan Boullion, Eric Caetano and Crystal Guillet from Algonquin Road PS explained their experiences with shared reading with buddies as well as shared reading in mathematics. Videos were shown to exhibit what shared reading looks like in a grade 7 mathematics classroom.

Trustees appreciated the information and had the opportunity to discuss and ask questions.
