#### 5. Trustees' Remarks/Questions

Trustee Clement asked about Espanola High School's graduation date. Director Blaseg advised that he would confirm with the principal.

Trustee Gibson asked if the board will be getting a claw back or compensation for strike days. Superintendent Bazinet advised that the board has not heard anything yet.

Trustee Gibson asked about staffing and how we proceed with the current times. Director Blaseg explained that we are required to abide by current collective agreements for staffing needs, which makes it difficult, especially if the proposed increase in class sizes is approved by the government.

#### 6. Chairperson's Remarks

A record number of students from Rainbow Schools have answered the call of the trades and signed Registered Training Agreements with local employers. Twenty-one students in Grades 11 and 12 are currently earning dual credits that will count towards their high school and college diplomas, while also qualifying for the academic portion of apprenticeships in the skilled trades of Heavy Duty Technician, Welder/Fitter, and General Carpentry. Students are attending classes at Cambrian College until June. In addition to classroom and shop time, they are completing Cooperative Education with a local employer. A sign-up ceremony was held at Cambrian College on February 4, 2020. Students and their parents had the opportunity to meet their co-op employers and tour Cambrian's skilled trades labs.

SHAD is an annual Canadian summer enrichment program for high-achieving high school students in July. The program is open to both Canadian and international students. The program is offered at 17 participating universities across Canada.

Two students from Lo-Ellen Park Secondary School have been accepted into the prestigious SHAD Canada program - Jack Moskalyk and Alec Dewulf. SHAD Canada is a science, technology, engineering, arts, mathematics (STEAM) and entrepreneurship program for students in Grades 10 and 11. Shad Canada's program attracts students with high aptitudes for risk taking, curiosity, excellence and resilience, and prepares them to take on social and economic challenges. The month-long program includes a real-world design challenge that asks students to

work on issues such as food security, water management and waste. Of the 2,500 applicants Canada-wide, about 1,000 students are accepted and we have two of them right here at Lo-Ellen Park Secondary School. Congratulations!

The last of the secondary school information nights takes place this week as Manitoulin Secondary School opens its doors on Thursday, February 20, 2020 at 6 pm. We thank all students and parents/guardians for participating in these information sessions that will help them make the transition into secondary school.

Parents/guardians of students with special needs and exceptionalities in the Rainbow District School Board are invited to provide input into the 2020-2021 Special Education Plan. Friday, February 28th is the deadline. The survey is available online at rainbowschools.ca.

On Thursday, February 27th, the Board's Environmental Committee invites staff and students to take part in International Polar Bear Day with the Polar Bear Challenge. Every year, this global event draws attention to the challenges polar bears face in a warming Arctic and what we can do to make a difference to reduce greenhouse gas emissions.

We remind parents/guardians to register their children for Kindergarten if they have not done so already. This helps us plan for the school year ahead. For children starting school for the very first time, there is an online registration form at rainbowschools.ca. Registering will secure a spot for your child at the Welcome to Kindergarten orientation sessions later this spring.

Mandate	Under the <i>Education Act</i> , Regulation 306 requires the Board submit a Special Education Plan for the school year 2020/2021. As part of this process, a Special Education budget must be developed.
Background	A review of special education programs and services is conducted on an annual basis. The Special Education Advisory Committee, principals, special education staff, and parents (127 responses) were invited to participate in the annual review. Their input is reflected in the Special Education Budget 2019-2020. In anticipation of the submission of the Special Education Plan by July 31, the Special Education Budget for 2020-2021 has been prepared in accordance with the Ministry of Education policy document <i>Standards for School Board Plans for Special Education</i> . The Special Education Budget 2020-2021 reflects programs and services for 1335 elementary and 936 secondary exceptional students, excluding Section 23 students. The Special Education Budget 2020-2021 amendments (see following page) are reflected in the Special Education Plan 2020-2021 which is available on the board website.

#### Amendments

A total of 169 (Full Time Equivalent) special education teachers have been allocated for 2020-2021. This includes 87 Resource Teachers, 46.5 Intensive Support Program Teachers, 12 Itinerant Teachers and 11 Section 23 teachers. This number represents an increase of 1 teacher from 2019-2020.

The number of (Full Time Equivalent) Educational Assistants remains at 179. This number represents Educational Assistants in Section 23 Programs. The number of of Communicative Disorder Assistants remains at 6.

#### Please note:

These allocations include section 23 teachers and educational assistants.

Further details to staffing for special education in elementary and secondary schools are included in the "Special Education Programs and Services", Section 8 and 11 of the Special Education Plan (available on the board website).

#### RAINBOW DISTRICT SCHOOL BOARD

#### BY-LAW NUMBER: 2020-01

A BY-LAW authorizing the Rainbow District School Board (the "Board") to borrow money pursuant to the provisions of section 247 of the Education Act (the "Act") for the raising of funds to finance certain permanent improvements as more particularly described in this By-Law.

#### WHEREAS:

- A. The Board has authorized the permanent improvements under the: School Condition Improvement Funding Program - \$12,556,783
- B. The Board wishes to apply to the Canadian Imperial Bank of Commerce ("CIBC") for a short term capital loan through the purchase of Bankers Acceptance for the purpose of financing the permanent improvements;
- C. The total cost of the projects is within the Board's Debt and Financial Obligation Limit as established by the Ministry of Education.

#### THEREFORE, BE IT RESOLVED as follows:

- The Treasurer and the Deputy Treasurer of the Board are authorized on behalf of the Board to borrow \$12,556,783 for permanent improvements in accordance with the Act, plus interest at a rate to be agreed upon from time to time with the CIBC and consistent with the short term borrowing direction provided by the Ministry of Education.
- 2. The Treasurer and the Deputy Treasurer are authorized for and on behalf of the Board to execute and deliver all such other documents and to do such other acts and things as may be necessary to give full effect to this By-Law.

We hereby certify that the foregoing is a true and complete copy of a By-Law of the Rainbow District School Board in the Province of Ontario, duly passed a meeting of the Board and that this By-Law is in full and effect.
