**REVISED LETTER –Exposure date extended to November 24, 2021.  
Isolation date extended up to and including December 4,  
2021.**

### Information for Bus High-Risk Contacts of a Case of COVID-19

An individual who attended the route **AM Bus L805** has tested positive for COVID-19 and your child/student/driver has been identified as a potential close contact.

Someone is considered a close contact if there is a chance that they had a high-risk exposure to someone who tested positive for COVID-19. This does not mean that they have COVID-19. However, they are at higher risk of getting infected with the virus. Not everyone who is a close contact will develop an infection, however, the directions in this letter will help protect them and others from COVID-19.

Public Health Sudbury & Districts has investigated and determined that the last date of high-risk exposure was **November 24, 2021**.

Regardless of the child/driver/student immunization status or they were previously infected with COVID-19, if they currently have or develop **any of the following symptoms (even if mild)**, they must immediately **isolate** and get **tested** as soon as possible.

#### Do not hesitate to get tested.

- Fever and/or chills (temperature of 37.8 degrees Celsius/ 100 degrees Fahrenheit)
- Cough or barking cough (croup)
- Shortness of breath
- Decrease or loss of taste or smell
- Nausea, vomiting and/or diarrhea
- Fatigue
- Muscle aches and pain
- Sore throat
- Runny or stuffy nose
- Abdominal pain
- Headache
- Conjunctivitis (pink eye)
- Decreased or lack of appetite

COVID-19 symptoms can also include the worsening of chronic health problems.

Please note that a legally enforceable [Class Order under the Health Protection and Promotion Act](#), is currently in effect. It requires all individuals in Public Health Sudbury & Districts’ service area who are either a case, potential case or contact of a case, to follow Public Health direction.

**It is critical that you carefully follow the Public Health direction in this letter. If the isolation period changes or is extended, you will be notified by letter.**

There are different rules for people who are fully immunized and those who are not. Public Health’s direction is based on your immunization status.

Please follow the scenario applicable to the child/driver’s situation.

**1. Instructions for Testing and Isolation - Fully immunized or Previously Positive**

If the child/driver is not immunocompromised and has been **fully immunized**<sup>1</sup> for COVID-19 or was a **confirmed positive**<sup>2</sup> case within the last 90 days, this section applies to them.

Public Health direction:

	<b>Child/driver has any <u>symptoms</u> of COVID-19 (listed above)</b>	<b>Child/driver does not have symptoms of COVID-19 (asymptomatic)</b>
<b>When should the child/driver get tested?</b>	<p>Test immediately. A PCR test is required. Rapid Antigen Tests are NOT to be used as they are only for screening purposes for individuals without symptoms and who are not contacts of a case. COVID-19 assessment centres are listed below.</p> <p>If they test <b>negative</b>, a repeat test is recommended on or after day 7 from the last date of exposure to a case (listed above).</p>	<p>PCR testing is recommended as soon as possible. Rapid Antigen Tests are NOT to be used as they are only for screening purposes for individuals without symptoms and who are not contacts of a case. <sup>1</sup> An individual is fully immunized if at least 14 days prior to their high-risk exposure they have received:

- the full series of a COVID-19 vaccine authorized by Health Canada, or any combination of such vaccines; OR
- one or two doses of a COVID-19 vaccine not authorized by Health Canada, followed by one dose of a COVID-19 mRNA vaccine authorized by Health Canada; OR
- three doses of a COVID-19 vaccine not authorized by Health Canada.

<sup>2</sup> An individual is considered previously positive if they tested positive for COVID-19 in the last 90 days and have since be cleared from their infection.

## 2. Instructions for Testing and Isolation – Not Fully Immunized or Previously Positive

If the child/driver is immunocompromised or has **NOT been fully immunized**<sup>3</sup> or was **not a previously positive**<sup>4</sup> case within the last 90 days, this section applies to them.

Public Health direction:

	<b>Child/driver has any <u>symptoms</u> of COVID-19 (listed above)</b>	<b>Child/driver does not have symptoms of COVID-19 (<u>asymptomatic</u>)</b>
<b>When should the child/driver get tested?</b>	<p>Test immediately. A PCR test is required (Rapid Antigen Tests are NOT to be used as they are only for screening purposes for individuals without symptoms and who are not contacts of a case). COVID-19 assessment centers are listed below.</p> <p>If they test <b>negative</b>, a repeat test is recommended on or after day 7 from the last date of exposure to a case (listed above).</p>	<p>Seek PCR testing on or after 7 days from the last date of exposure to a case (listed above).</p> <p>Rapid Antigen Tests are NOT to be used as they are only for screening purposes for individuals without symptoms and who are not contacts of a case.</p> <p>COVID-19 assessment centers are listed below.</p>

	If you do <b>not get tested</b> , you must isolate immediately and contact Public Health.	
<b>Does the child/driver need to isolate?</b>	<p>They are required to <u>self-isolate</u> immediately while awaiting their test results.</p> <p>If they test <b>negative</b> and if they have no new or worsening symptoms, they must continue to <u>self-isolate</u> up to and including <b>December 4, 2021</b>. They may stop self-isolating on <b>December 5, 2021</b>.</p> <p>If they experience new or worsening symptoms after their negative test, contact Public Health for further assessment and direction.</p> <p>If they test <b>positive</b>, continue to <u>self-isolate</u>. Public Health will contact you within 24 hours to advise you that they must isolate for at least 10 days. The Public Health staff will provide you the date that their isolation will end in addition to further information you require for their self-isolation.</p>	
<b>When can the child/driver return to school/daycare/work?</b>	<p>If they test <b>negative</b>, and provided no new or worsening symptoms, they can return on <b>December 5, 2021</b> as long as they have no fever and symptoms have been improving for at least 24 hours, or 48 hours for gastrointestinal symptoms (e.g., vomiting, diarrhea).</p> <p>If they test <b>positive</b> OR <b>do not get tested</b>, they can return following a 10-day self-isolation period and as directed by Public Health.</p>	
<b>Do household contacts members need to self-isolate?</b>	<p>Household members are <u>not required to self-isolate</u> if they are <b>fully immunized</b><sup>1</sup> or previously positive within the past 90 days<sup>2</sup> unless they develop symptoms.</p> <p>Household members who are <b>not fully immunized</b><sup>3</sup> and not previously positive within the past 90 days<sup>4</sup>:</p> <ul style="list-style-type: none"> <li>• Must <u>isolate</u> while the child is awaiting their test results.</li> <li>• Must <u>isolate</u> if the child tests <b>positive</b>.</li> <li>• Can stop isolating if the child tests <b>negative</b>, but should <u>stay home except for essential reasons</u> (e.g. school, work, child care).</li> </ul>	<p>Household members are <u>not required to self-isolate</u> if they are <b>fully immunized</b><sup>1</sup> or previously positive within the past 90 days<sup>2</sup> unless they develop symptoms.</p> <p>Household members who are <b>not fully immunized</b><sup>3</sup> and who were not previously positive<sup>4</sup> within the past 90 days:</p> <ul style="list-style-type: none"> <li>• Should <u>stay home except for essential reasons</u> (e.g. school, work, child care) if the child is <b>asymptomatic</b> OR tests <b>negative</b>.</li> </ul>

Call 911 or take your child to the nearest hospital immediately if your child is experiencing any of the following symptoms:

- Severe difficulty breathing (struggling for each breath, can only speak in single words)
- Severe chest pain (constant tightness or crushing sensation)
- Feeling confused or unsure of where they are
- Losing consciousness
