

Community Use of Lancer Dome

This procedure includes measures taken by Rainbow District School Board to ensure permit holders who use the Lancer Dome have access to a safe environment and that health and safety controls are implemented in alignment with [Regulation 364/20: Rules for Areas at Step 3 and at the Roadmap Exit Step](#).

As the COVID-19 pandemic evolves, Rainbow District School Board continues to follow the guidance of the Province of Ontario and Public Health Sudbury and Districts.

Permit holders will be responsible for implementing health and safety measures and for developing a Safety Plan for their team, club, or organization. **The Safety Plan must be sent to the Rainbow District School Board contact as part of the permit application process.**

The Safety Plan must include the following:

- Participants must conduct COVID-19 screening prior to arriving at the dome using the [Provincial Customer Screening Tool](#).
 - Results must be communicated to the Team/Club Lead.
 - The Team/Club lead will confirm that all participants have passed the Provincial Customer Screening Tool upon arrival by signing an attestation provided by Rainbow District School Board staff on site at the dome.
- Spectators are not permitted. Note: Exemptions can be made if participants require assistance.
- Participants should come 'Ready to Play' as change rooms will be closed.
- All participants must wear a mask/face covering at all times when not engaged in play, including on the bench and in the field house.
- Physical distancing between other users must be practised at all times.
- Participants in halves are not to interact with each other.
- Participants must remain on their designated portion of the field.
- A process is required for assisting/isolating participants who may become symptomatic while on site.
- Participants are encouraged to practice hand hygiene upon entry to the field house and the dome.
- Playing and/or training equipment must be cleaned and disinfected between use.
- Sharing of water bottles is not permitted.
- Water breaks must be held in an area where each participant can physically distance themselves from one another.
- Participants must arrive no earlier than 10 minutes before the start of booking and must leave within 10 minutes after the booking.

Community Use of Lancer Dome

- Maximum of 20 participants per team is allowed.
- Home teams must use the right side of the field and visiting teams are to use the left side.
- Teams may use the centre field while they wait for their game time.
- It is the responsibility of the Team/Club Lead to ensure all health and safety protocols are followed by their participants at all times. Failure to do so may result in the loss of permit.

Rainbow District School Board Roles and Responsibilities

- All Rainbow District School Board staff are required to wear a medical grade mask at all times. Eye protection is required within the dome when physical distancing cannot be maintained.
- Staff will be responsible for regular cleaning and disinfecting of all high touch surfaces within the dome and field house.
- Staff are required to pass daily screening.
- Hand sanitizer will be available at the entrance of the field house and at the entrance/exit of the dome.
- Field separation barriers must remain in place unless the full field is booked.
- Only fields 1 and 3 will be permitted for use. The centre field (field 2) is not available at this time. Field 2 is being used as a holding area for teams waiting to play.

Rainbow District School Board employees will not be responsible for enforcing COVID-19 protocols outlined in each organization or club's Safety Plan.

Failure to comply with the Safety Plan may result in loss of permit.
