#### 2. Director's Remarks

Director Bourget thanked our schools, Finance department, Manager Nancy Cecchetto and Superintendent of Business for all of the hard work in finalizing the financial statements during the challenges of a change over to Aspen, and for the continued work on the 2021-2022 school year financials.

Director Bourget pointed out that with June approaching, so are graduations which are being planned as in-person celebrations and Trustees can look forward to receiving invitations to attend.

There has been a lot of hard work on the provincial census and Director Bourget thanked Superintendent Noble, trustees and staff for the ongoing work.

He reminded that at our next meeting, we will be sharing a presentation to celebrate this year's Board award winners.

#### 3. Other Items

**OPSBA Director** – Trustee Kosmerly shared that she attended the OPSBA Board of Directors meeting on April 29 and 30th. At the meeting, OPSBA board's new vision, mission and values was approved. The Board of Directors also approved the OPSBA operating budget for 2022-23, noting that membership dues for school boards will not increase next year. The Board also approved 10 of the recommendations that came from the Equity, Diversity and Inclusion audit. The OPSBA AGM is on June 9-11 in Ottawa where elections will be held for executive and regional positions. At this meeting there will be 6 member board resolutions brought forward for approval. Trustee Kosmerly will be in discussions with trustees for their input into these motions. OPSBA is not providing virtual options for hybrid meetings, at this time, due to costs.

**Student Trustee** – Student Trustee Yao reported that the Stand Up Speak Out conference is this Thursday at Cambrian College Amphitheatre. Senators have been working very hard in preparation for this in-person conference. The Student Senate has also been working on an initiative that fights for menstrual equity and against period poverty. High schools in Sudbury hosted donation drives and collected a total of 846 period products that will be given to the Sudbury Women's Centre. Manitoulin Secondary School hosted their own separate events and they will donate to their local centre and to the school's wellness locker.

Trustee Hunda affirmed how hard the student senators have worked and extended an invitation to trustees to join the conference. Trustee Hunda attended a reading picnic at Princess Anne Public School and wanted to thank the staff for the hard work they did during the education week activities.

This is an opportunity for families to meet educators, tour the school, visit the Kindergarten classroom, connect with classmates, and get excited about starting school this fall. Mandate	Under the <i>Education Act</i> , Regulation 306 requires the Board submit a Special Education Plan for the school year 2022/2023. As part of this process, a Special Education budget must be developed.
Background	A review of special education programs and services is conducted on an annual basis. The Special Education Advisory Committee, principals, special education staff, and parents (177 responses) were invited to participate in the annual review. Their input is reflected in the Special Education Budget 2022-2023. In anticipation of the submission of the Special Education Plan by July 31, the Special Education Budget for 2022-2023 has been prepared in accordance with the Ministry of Education policy document <i>Standards for School Board Plans for Special Education</i> . The Special Education Budget 2022-2023 reflects programs and services for 1231 elementary and 858 secondary exceptional students, excluding Section 23 students.

#### **Amendments**

A total of 206 (Full Time Equivalent) special education teachers have been allocated for 2022-2023. This includes 104 Resource Teachers, 79 Intensive Support Program Teachers (this includes Section 23 teachers), and 12 Itinerant Teachers. This number represents an increase of 32 teachers from 2021-2022.

The number of (Full Time Equivalent) Educational Assistants is 204. This number includes Educational Assistants in Section 23 Programs. The number of of Communicative Disorder Assistants remains at 6.

These allocations include section 23 teachers and educational assistants.

**AND WHEREAS** section 81.1(1) of the Municipal Elections Act, 2006, as amended requires the municipality to establish a Compliance Audit Committee;

**AND WHEREAS** this By-law hereto complies with Section 270 of the Municipal Act, 2001 with respect to the manner in which the municipality will try to ensure that it is accountable to the public for its actions and the manner in which the municipality will try to ensure that its actions are transparent to the public;

NOW THEREFORE RAINBOW DISTRICT SCHOOL BOARD HEREBY ENACTS AS FOLLOWS:

- 1. The Compliance Audit Committee of the Greater City of Sudbury shall be adopted as the Compliance Audit Committee of the Rainbow District School Board for the election of Trustees in the 2022 Municipal Election conducted by the City of Greater Sudbury for Areas 1, 2, 3, 4, 5 and 6.
- 2. The Compliance Audit Committee of the Town of Northeastern Manitoulin and The Islands shall be adopted as the Compliance Audit Committee of the Rainbow District School Board for the election of Trustees in the 2022 Municipal Election conducted by the Town of Northeastern Manitoulin and The Islands for Area 7.
- 3. The Compliance Audit Committee of the Town of Espanola shall be adopted as the Compliance Audit Committee of the Rainbow District School Board for the election of Trustees in the 2022 Municipal Election conducted by the Town of Espanola for Area 8.
- 4. This By-law shall take effect on the date of final passing thereof.

# 10.0 Superintendent's Report

Superintendent Wachnuk has received and reviewed the 177 Special Education Surveys that were submitted by parents.

Superintendent Wachnuk explained that additional virtual Intensive Support classrooms and/or Special Education staff will be required. They are needed to accommodate the increased number of students with special education needs attending school virtually during the 2022-23 school year.

Superintendent Wachnuk reminded the SEAC that the proposed 2022-2023 Special Education Budget along with the proposed 2022-2023 Special Education Staffing will be presented at the May 4, 2022 SEAC meeting.

# 11.0 Special Education Staff Report

Principal McDonald explained that a Rainbow Literacy Intervention Task Force has recently been created. Appropriate benchmarks, screening tools, interventions and assessments will be developed for Kindergarten to grade 2 students in Regular and French Immersion Programs. Program and Special Education staff will work as a team to support all students.

Principal McDonald provided an overview of the Entry To School Program for children who are registered in the Ontario Autism Program. Child & Community Resources (CCR) is the lead agency. Ten eligible Rainbow preschoolers will participate beginning in April for half-days at Child Care and EarlyON Sites. For six months, the children will receive services through various community partners (Wordplay, Children's Treatment Centre, ABA Northern Services and Mariani and Associates). In September, Rainbow staff will work collaboratively with the involved community partners to ensure a smooth transition into school.

#### 1. Welcome from PIC Chair Natasha Delaney

Natasha Delaney welcomed everyone to the PIC Meeting.

#### 2. Introductions

The Chair invited new participants to introduce themselves.

#### 3. Presentations: Outdoor Classrooms by Kindergarten Consultant Julie Kelly

Julie Kelly focused on the benefits of bringing children outdoors, how teachers support outdoor learning, authentic interactions, different perspectives of outdoor learning and what the research says. Children build relationships in the outdoors, with each other and the natural world. Educators build on those relationships both outdoors and inside the classroom. In the outdoors, children wonder, ask questions, inquire, explore, notice, name, research, seek and connect. They create, invent, imagine, discover, build, forage and move. This fosters love, empathy, compassion, communication, conversation, deeper thinking, mental health and well-being, and a desire to care for the land. Through adventure, children take risks. Adventure also fosters independence, creativity, imagination and self-regulation skills.

The presentation, which was shared with PIC members and posted on the board website, included links to Outdoor Learning in the Kindergarten Curriculum, Pilot Projects on Outdoor Play, the Children's Outdoor Charter of Ontario, the Junction Creek project funded by the Canada Healthy Community Initiative as well as numerous resources. Through dynamic visuals, Julie Kelly presented different perspectives on outdoor learning - question/inquiry/research, ecological, artistic, Indigenous, mindfulness and gross motor - with examples. The research confirms that outdoor learning, which invites children to use their natural curiosity to test theories through active engagement, builds a solid foundation for later learning. Playing together, being outdoors, learning from each other, having fun, and enjoying childhood itself enhances quality of life and provides memorable experiences. This has a positive impact on student achievement and well-being.

PIC members enjoyed the presentation and expressed positive feedback for outdoor learning. Parents said they look forward to sharing the presentation with their respective School Councils and thanked Julie Kelly for including links to learn more.

#### Earth Day - April 22, 2022

EcoSchools will host a special Earth Day live-streamed event with Severn Cullis-Suzuki, Executive Director of the David Suzuki Foundation on Thursday, April 21, 2022 for schools that sign up to complete a community clean-up this year. #### Virtual Presentation with Kevin J. Cameron on April 26 at 6:30 pm
