C. **PRESENTATIONS**

1. Show & Tell "Taking Care of Mother Earth – Shkagamikwe"

Director Bourget introduced Ryan Lafraniere, Vice Principal, Lockerby Composite School and Hazel Fox-Recollet, Indigenous System Support worker, both whom are members of the Environmental Education Committee, to share the highlights of where the Board is on environmental education and sustainability.

In 2019, Rainbow District School Board declared a climate emergency which brought about the Climate Action Plan that was approved in 2021. In 2022, Rainbow

had the distinction of being one of two school boards in Canada to have all schools of the board become EcoSchools certified.

Hazel Fox-Recollet shared the indigenous perspectives that students are introduced to from teachings, language, song and storytelling through the monthly environmental eco challenges. One of the newest initiatives the committee is launching is a School-Community Traditional Harvest Celebration, to experience what harvesting is all about and celebrate the sustenance and medicine we receive from the land.

Vice Principal Lafraniere provided highlights from the past year and introduced students of the Eco-Clubs from Larchwood Public School, Queen Elizabeth Public School, Central Manitoulin Public School and Algonquin Public School who presented some of the activities and challenges they have completed over this school year.

Trustees were given the opportunity to ask questions and expressed their gratitude to all of the students and teachers for providing a wonderful presentation.

2. Enrolment

Director Bourget introduced Adam Guilbault, Superintendent of Business, who provided an enrolment update for 2022-2023 school year.

Superintendent Guilbault shared the data from the October 31st enrolment submission to the Ministry, which generates the GSN (Grant for Student Needs) funding.

The board saw an increase in enrolment in both the elementary and secondary panels and a reduction in the number of remote learners and those who are homeschooled.

Trustees had an opportunity to comment and ask questions.
