Literacy and Numeracy – Superintendents Fisher & McNamara

Superintendent McNamara and Superintendent Fisher welcomed Dan Koziar, Principal of Program and Melanie Bertrand, Principal of Student Success, who presented overviews of the literacy and numeracy supports and initiatives in Rainbow Schools for the 2023-2024 school year.

Principal Koziar shared how staff are collaborating in the elementary panel to ensure positive outcomes for students as they develop their skills in language and mathematics,

through professional learning initiatives, and ongoing professional development using coaching and consulting models.

Principal Bertrand shared that as we enter subsequent years of destreamed Math and English for grade 9, curriculum changes are also being implemented in the secondary panel. She shared how our system initiatives and supports for literacy and numeracy continue to advance our board priorities.
