

Additional staffing in place in elementary schools starting tomorrow.

Exec Council School Visits - Visiting schools to connect with staff and students. As part of our restructuring and plans for this year, the Executive Council is in schools each Wednesday and Thursday. Visits have been very well received and it is certainly amazing to see all of the great things happening in Rainbow Schools.

Fall Athletics are underway. Schools clubs and activities are happening and our students are benefiting from the activities and experiences.

As mentioned, one more reminder that this Thursday, at the Board office we will host our third annual Sunrise Ceremony at 6:45 a.m. I would like to thank Hazel Fox-Recollet and Nicole Nicholas for their leadership in making this possible.

Finally, I would like to take this opportunity to express my appreciation to our board of Trustees and all staff for their dedication and commitment to student learning and well-being. Each day, our staff makes a difference in the lives of our students. It is a privilege to serve the board of Trustees and our staff. You exemplify what reaching minds and touching hearts is all about. Thank you!!

10. Other Items

OPSBA Director – Trustee Kosmerly attended the OPSBA Board of Director's meeting over the weekend. The meeting began with an acknowledgment on the passing of 2 trustees over the summer, one being Trustee Morrison and they expressed their heartfelt condolences on behalf of Ontario school boards.

Trustee Kosmerly shared that a mass tort litigation is being launched against social media companies (Snapchat and Meta) for knowingly promoting dangerous and controversial content to children. OPSBA understands there is no fee for school boards to join the lawsuit. There will be a town hall session with the law firm, school board directors and board chairs on October 10th (tentatively) to provide information and answer questions.

The Ministry will begin consultations under Bill 98, one being a session for director performance appraisals that Trustee Kosmerly will be attending. Information was shared with all trustees on the consultations that are open to all.

Financial support was offered to boards for Indigenous Student Trustees to attend the OPSBA conference in Sault Ste Marie.

The next PES conference will be a 2 day conference on January 25-26, 2024, and the next Board of Directors meeting will be on November 26, 2023 in Toronto.

The first of 3 speakers series webinars was held September 20th and the remaining 2 sessions will take place on October 18th and November 22nd. There is no cost to trustees to join.

Student Trustee – Student Trustee Greene provided an update from the first student senate meeting and shared that senate is working on a survival guide for high schools that includes a slideshow with QR codes that will link to videos and information for students. Senate is also creating a social media post for the National Day for Truth and Reconciliation.

Trustee Farrow had a wonderful time visiting Jean Hanson Public School and was given a tour of the facility. He shared that it is an incredible school.

Trustee Kosmerly gave a shout out to Valley View Public School where students taped Principal Carr to the wall as part of a challenge to raise money for the Terry Fox Foundation, in which they raised over \$5,464.

Trustee Hunda shared her appreciation for the presentation on the school board facilities and seeing all the developments of the projects, including getting Lasalle completed for the start of the school year.

Trustee Corbiere-Addison visited some schools on Manitoulin Island and shared her appreciation on seeing the work on the Fall Fairs and the Terry Fox run. She expressed her appreciation to all the volunteers who help with events such as these.

Student Trustee Greene shared that Sudbury Secondary School hosted the school's first Multicultural Fair, which was a great success.

Rainbow Schools will mark the **National Day for Truth and Reconciliation** on Thursday, September 28th. It is a time to acknowledge the Survivors of residential schools who had the courage to share their stories. It is also a time to remember the children who never made it home. Staff and students will come together and wear orange as a symbol of truth on our path towards reconciliation.

There will be no school for students this Friday, September 29th for a **Professional Activity Day**. We remind parents/guardians that information about professional learning is posted on rainbowschools.ca.

Ontario universities will host an information session to help secondary students plan their post-secondary journey. The **Ontario Universities' Fair** will be at Laurentian University on Thursday, October 5th from 6 pm to 8 pm. Parents/guardians are encouraged to attend.

As a reminder, all schools will be closed for **Thanksgiving** on Monday, October 9th.

This month, schools have been busy preparing for the **Traditional Harvest Celebration** at Lockerby Composite School on Friday, October 13th. Outstanding articles and entries from School Fall Fairs will be showcased at the event, where community harvesters, agriculturalists, botanists and environmental advocates will share their skills and knowledge about the benefits of traditional harvesting and local farming.

Parents/guardians are invited to learn about relationships, belonging and connection with renowned specialist in child psychiatry Dr. Jean Clinton as part of the **Parent Involvement Committee's Annual General Meeting** on Tuesday, October 17th. The election of PIC members will begin at 6 pm followed by the keynote address at 7 pm. The live presentation will be held in person at Sudbury Secondary School's Sheridan Auditorium. Parents/guardians in Espanola and Manitoulin are invited to gather at Espanola High School and Manitoulin Secondary School to participate.

Students will take part in the **HEADSTRONG Summit** on Tuesday, October 23rd from 8:30 am to 3 pm at Cambrian College. The goal is to teach students how to recognize the signs of mental health and reduce stigma. Students will be inspired to become leaders to foster wellness in their schools.

- Next year, we will be offering some secondary online courses through eLearning.
 Students will be scheduled for a period of the day and a teacher will be funded to be in the classroom to support.
- For the 2022-2023 school year we offer in person Anishinaabemowin at the following schools:
 - Manitoulin Secondary, Lasalle Secondary, Confederation Secondary, Sudbury Secondary School, Lockerby Composite School, Walden PS, Queen Elizabeth II PS, RH Murray PS, AB Ellis PS, Adamsdale PS, Princess Anne PS, Churchill PS, Lansdowne PS, Lively District Elementary (Gr. ¾), Assiginack PS, Little Current PS., Lasalle Elementary (Gr. ¾).
- Discussion around qualifications for unqualified language teachers.
- Question about unqualified language teacher's salary. With no degree and no experience, teachers are usually placed at level A and 0 years experience.
- Kathy Dokis is asking people that know language speakers to pass along these names to her.
- Martin Bayer suggested creating an Anishinaabemowin sub committee.

10.0 Superintendent's Report

No Superintendent's Report was provided.

11.0 Special Education Staff Report

Principal Williamson shared the SEAC Survey results. SEAC meetings will remain from 12pm-2pm on the first Wednesday of every month. They will continue to be held virtually.

Principal Williamson shared information on school-based clinics. There are currently three school-based clinics in the Rainbow District School Board, located at Princess Anne Public School, Chelmsford Valley District Composite School, and the Ruth MacMillan Centre. Pediatrician Dr. Baron supports these clinics. Principal Williamson and Dr. Baron recently collaborated on a proposal for the Models of Care Innovative Fund in hopes to expand the school-based clinics to more schools in the Rainbow District School Board. The proposal is seeking financial support to hire an administrative assistant, Nurse Practitioner, and basic medical equipment that is required for routine medical exams in schools. Principal Williamson is hoping to receive information regarding the proposal by the end of September 2023.

Principal Williamson shared an update regarding Project Search. There will be ten new interns for the 2023-2024 school year. Interns and their families have been invited to the Signing Day ceremony and Parent Information session this afternoon at Health Sciences North. Principal Williamson also shared that the Board has been approved to explore the possibility of an additional Project Search site for the 2024-2025 school year. More information will be shared about this at a later date.

Principal Williamson shared information regarding the recent Professional Activity Days on September 1 and 5, 2023. Special Education Board staff were excited to provide direct training to all staff across the Board. Training sessions were provided in the areas of classroom management, Intensive Support Program

information and support, learning spaces for students with exceptionalities, the RISE Individual Education Plan platform and best practices around Safety Plans for students.

Principal Wiliamson shared information on new reading pilot programs being offered in Intensive Support Program classrooms in the Board. There is one reading pilot program (Remediation+) running in the elementary panel, a total of eight programs are running across four different schools. The focus of this program is around developing phonemic awareness, decoding and spelling skills. There is also one reading pilot program (SpellRead) being offered at the secondary level, a total of four programs are being provided across four different schools. SpellRead is an intervention for students with difficulties in word reading, accuracy or fluency. Both interventions were developed in Canada, have been approved by the Ministry of Education and were selected in the Right to Read report. Training for staff participating in the pilot programs will wrap up this month.

12.0 Board Report

Trustee Corbiere-Addison shared the Board Report at the September 13, 2023 SEAC meeting. At the June Board meeting Trustees discussed the budgets and outlined the impacts of the new funding formula. Trustee Corbiere-Addison attended the August ITC meeting in Toronto where information was shared on GSN funding outcomes across the province. The Rainbow District School Board will be in a position of significant financial loss if the funding is not corrected.

Trustee Corbiere-Addison shared that 78 new teachers and 58 new support staff were hired at the Rainbow District School Board for the 2023-2024 school year. New staff participated in an orientation day in August.

Trustee Corbiere-Addison shared that the Rainbow District School Board opened a new elementary school this year - Lasalle Elementary School. The new school currently has 350 French Immersion students.

Trustee Corbiere-Addison shared that predicted enrollment at the Rainbow District School Board totals 13,997 students, which includes 9,133 at the elementary level and 4,864 at the secondary level. Less than 1% of the predicted enrollment will be participating in remote learning this school year.

Trustee Corbiere-Addison shared that Fall Fairs and Harvest Celebrations are being encouraged in all schools throughout the Board this school year.

Trustee Corbiere-Addision shared that the Parent Involvement Committee (PIC) annual General Meeting will take place on October 17, 2023 at Sudbury Secondary School. The meeting will include Keynote Speaker Dr. Jean Clinton from 7 to 9pm.

Trustee Debassige shared condolences and kind words on the passing of Trustee Morrison on September 5, 2023. At the September 12, 2023 Strategic Planning Meeting Trustees expressed many kind sentiments and memories of Trustee Morrison. She will be remembered as a staunch supporter for all students in the Rainbow District School Board.

13.0 Chairperson's Remarks

R. Silvestri shared W. Larouche's condolences regarding the passing of Trustee Morrison. Trustee Morrison played an active role on the SEAC Committee and in supporting all students with special needs.

14.0 Association Reports

March of Dimes Canada - J. Way

Direct referrals to March of Dimes from RDSB staff has increased significantly in the past couple years, further fostering the great collaboration forged between the organizations. School staff continue to refer a wide variety of students from across the Board. March of Dimes has even started doing student intake meetings directly at the school to better support the new referrals.

Children's Community Network - S. Roussy

September is Fetal Alcohol Spectrum Disorder month. The purpose of the campaign is to promote FASD awareness throughout the community. S. Roussy will be providing FASD training on the Neurobehavioural Model each week for the month of September. These virtual sessions are available to anyone looking to learn more about Fetal Alcohol Spectrum Disorder.

NOARC - R. Silvestri

NOARC and the Learning Disabilities Association of Sudbury have collaborated to create a learning styles protocol for classroom teachers to get to know their students' learning styles better. The protocol includes information on student

preferences, social interaction skills, information processing, cognitive styles and how to measure abilities in the classroom.

Down Syndrome Association of Sudbury - J. Contini
The Down Syndrome Association of Sudbury will hold their annual walk on
October 2, 2023 at Lockerby Composite School. The walk is open to the public
and will run from 11am to 2pm that day.

15.0 Correspondence Addressed to SEAC

G. Cacciotti shared a letter of correspondence from the Near North Board regarding SIP funding. R. Silvestri discussed whether SEAC would want to vote on supporting this, and deferred this to a future meeting date. Trustee Dewar recommended we share the letter with the Board. Trustee Corbiere-Addison requested information from Superintendent Gibeault regarding the effects of changes to SIP funding on the Rainbow District School Board.
