#### 1. 2023-2024 School Year Update

Director Bourget provided an update on teachable moments, new initiatives and school celebrations taking place at Rainbow Schools.

Director Bourget welcomed Trustee Alex McCauley who was sworn in on November 13<sup>th</sup> by Madame Justice Patricia Hennessy.

With Literacy and Numeracy the focus of the November 10<sup>th</sup> P.A. Day, schools reviewed their progress in these areas focussing on the implementation of high-yield teaching strategies. He shared examples of how schools are honing their math skills. Also on the P.A. day, Grade 7/8 teachers were provided training on the Ministry-mandated Mental Health literacy modules that will be delivered to grade 7 and 9 students to further support student well-being.

Treaties Recognition Week was held from November 5 to 11, 2023 with staff and students continuing their learning about treaties and the importance of the treaty relationship. Schools also observed Remembrance Day on Thursday, November 9<sup>th</sup> and flags flew at half-mast in Sudbury, Espanola and Manitoulin Island from November 8<sup>th</sup> throughout the weekend, to mark Indigenous Veterans Day.

A new "Think Trades" trailer has started touring elementary school to introduce the trades to intermediate students, allowing them to participate in activities related to the skilled trades, OYAP and SHSMs.

Director Bourget shared his pleasure of participating in a presentation on November 9<sup>th</sup> as Lockerby Composite School was recognized for its annual cancer drive which has raised over one million dollars for pediatric cancer research and care programs in partnership with the Northern Cancer Foundation.

Director Bourget also spoke about the "Next Stop: Grade 9" event that took place on November 14<sup>th</sup> at Cambrian College, where grade 7 and 8 students and families could speak with school administrators on site to obtain information about our schools and programs.

He also shared an update on the Dare to Care program that was piloted in 12 elementary schools last year has been implemented in all K to 8 schools for the current school year.

Director Bourget also shared that Lively District Secondary School was the recipient of a \$10,000 donation from Major Drilling to go towards the purchase and installation of a new scoreboard and shot clocks for the gym.

Lastly, Kindergarten Information Nights for students starting school in September 2024 will take place on January 17, 2024 for the English Program and January 18, 2024 for French Immersion. Schools offering both English and French Immersion will host one Information Night on January 18, 2024. All parents/guardians and their children are welcome.

The value of extracurricular activities is very significant and I thank our volunteers, staff, administrators and Trustees for your support of extracurricular activities for our students.

I would conclude my comments by sharing my gratitude to the board of Trustees for your leadership and support of our staff, students and families. Thank you for all you do. We appreciate you!

### 5. Other Items

**OPSBA Director** – Trustee Kosmerly shared that a tentative agreement for ETFO teachers has been reached and more information will be shared in the coming weeks. The 3<sup>rd</sup> of three OPSBA "Good Governance" workshops will be held online tomorrow. On November 14<sup>th</sup>, OPSBA submitted feedback regarding the 2024-25 GSNs, and advised the document is available for viewing on the OPSBA website. On November 17<sup>th</sup>, OPSBA submitted a response to the Ministry proposal regarding the introduction of an Accelerated Apprentice Pathways. Trustee Kosmerly will share if interested to read the proposal and response. The deadline to submit feedback to the Skills Development and Apprenticeship branch is November 24<sup>th</sup>.
