I would like to thank Superintendent Guilbault and Manager Nancy Cecchetto and the Finance Department team for the excellent work in preparing for the audit. The Clean Audit Report is the highest level of assurance and is a testament to the good practices and work that is being done.

Also would like to thank Principal Brenda Carr for assembling a team of Rainbow staff and thank the staff who came out to volunteer at the Sudbury Lions/MCTV Christmas Telethon. We currently have a Food Drive also underway lead by Vice-Principals Brad Smith of Lockerby and Andrew Kendall of Espanola and held a Coats for Kids campaign lead by Principal James Norrie. Rainbow District School Board cares about our communities and I am grateful to all staff, students and volunteers for their efforts to provide support and show kindness over the holiday season.

I would like to take this opportunity to thank the Board of Trustees, Executive Council, our School Administrators, our teachers and all support staff for the incredible work you do each and every day in support of students and student learning.

There are many events in the upcoming weeks for students and staff to enjoy. A very well earned break is just around the corner. ## 6. Other Items

**OPSBA Director -** Trustee Kosmerly attended the Board of Directors meeting in Toronto on November 26th followed by OPSBA's Day of Advocacy on November 27th. At the meeting, OPSBA approved specialized training for Board Chairs that will take place the day after the PES conference. There is still no update from the Ministry on electronic meetings or about consultation on the Trustee code of conduct. There are 2 online surveys that OPSBA is encouraging trustees to complete, with direct links found in the November 24th provincial update email. Nominations open in December for 6 OPSBA awards and 2 leadership scholarships for students. The Board of Directors approved a new "Legal Action Fund" policy and are seeking feedback from trustees on a new draft policy on restricted reserves. Trustee Kosmerly will share the draft with trustees to provide feedback directly to OPSBA. The Canadian School Board Association recently completed a research project on student success in provinces where there are no elected trustees. The report is currently being reviewed by OPSBA, but an early read shows the need for locally elected school board trustees. On the November 27th Advocacy Day, Trustee Kosmerly attended a question period and met with 2 local MPPs, where discussion included concerns around Special Education funding and Indigenous funding, the proposed accelerated apprenticeship program and student transportation.

**Student Trustee** – Student Trustee Greene shared many secondary schools participated in Diabetes Awareness Month initiatives and thanked senators for spreading awareness and information within their schools. Student Senate received a presentation from Senator Alexandra Wilson-Zegil on "Women in Stem Fields" who also created posters and worked with elementary teachers on Manitoulin Island to create assignments and lesson plans to encourage female learners to join and feel confident in STEM spaces. Student Senate continues to work on the year-end conference with more details to come. Student Trustee Greene shared they are proud of senators as it takes a lot of courage to come into the Boardroom as grade 10, 11 and 12 students and they are doing an incredible job.



## **Objectives**

## This Plan:

- Describes the process by which the Rainbow District School Board will identify, remove and prevent barriers;
- Reviews recent efforts of the Rainbow District School Board to remove and prevent barriers;
- Describes the measures the Rainbow District School Board will take in the period 2023-2027 to identify, remove and prevent barriers;
- Makes a commitment to update the Wheelchair Accessibility and Lockdown Tracking reports within the multi-year accessibility plan, annually;
- Makes a commitment to review and update the multi-year accessibility plan at least once every 5 years;
- Describes how the Rainbow School Board will make this accessibility plan available to the public.

## **Commitment to Accessibility Planning**

This plan will be established, reviewed and updated in consultation with persons with disabilities, the Board's Special Education Advisory Committee, Parent Involvement Committee and the Accessibility Planning Committee. It will be presented to the Board for approval.

The Rainbow District School Board is committed to:

- Maintaining an Accessibility Planning Committee;
- Continuing the process of consulting with the Special Education Advisory Committee and with persons with disabilities;
- Ensuring, wherever practicable, that Board policies, procedures and practices are consistent with the principles of accessibility and inclusive/universal design. The Accessibility Planning

Committee will provide input re: accessibility issues, where appropriate, with regard to new policies and procedures and to those under review;

• Improving access to facilities, policies, programs, practices and services for students, staff, parents/guardians, volunteers and members of the community. Consideration of ongoing identification of barriers will be the responsibility of the Accessibility Planning and will, wherever practicable, be incorporated in the multi-year plan.

The Director of Education has authorized the Accessibility Committee to review and update the Multi-Year Accessibility Plan that will enable the Rainbow District School Board to meet these commitments.

## **Description of Rainbow District School Board**

Rainbow District School Board covers a geographic area of more than 14,757 square kilometers in Sudbury, Espanola, Manitoulin Island and Shining Tree.

Nine trustees govern Rainbow District School Board, including a trustee who represents 11 First Nations who have educational service agreements with the Board, and two student trustees. Elected every four years, the trustees are the public's voice at the Board.

Rainbow District School Board is the largest school board in Northern Ontario with 28 elementary schools and 9 secondary schools. The Board also operates other educational programs – Barrydowne College, Cecil Facer Secondary School, Frank Flowers School, N'Swakamok Native Alternative School, Ruth MacMillan Centre, Child Adolescent Mental Health Program (CAMHP), Children's Treatment Centre, O'Connor Park, Restart, SHILO, Attendance Centre and Mishko-Deh-Wendam.

Rainbow District School Board had 14,285 students on October 31, 2023, with a staff of approximately 1,777. The approved budget for 2022-2023 was \$235.3 million.

In Rainbow Schools, programs focus on student success from Kindergarten to Grade 12 in English and French Immersion.

## Strategy for prevention and removal of barriers

Beginning on September 1, 2001, the principles of inclusionary practice, freedom from barriers and accessible environments have informed all Rainbow District School Board policies, programs, procedures and services. Through the annual accessibility plan status report process implemented under the *Ontarians with Disabilities Act, 2001*, the Rainbow District School Board's programming, policies and practices have been assessed to ensure continuous improvement in accessibility. This process will continue through the establishment of a multi-year accessibility plan which places particular emphasis on the provisions of the regulations made under the AODA with

regard to customer service, information and communications, employment and school transportation.

## **Barrier Identification Methodologies**

The Accessibility Planning Committee uses the following barrier-identification methods:

Group	Methods
Students	Barriers to accessibility are identified by students, parents and school staff. Facilities, Special Education and staff work with stakeholders to remove/prevent barriers and develop accommodation plans.
Staff	Employee and Human Resources staff identify barriers, restrictions and limitations and develop accommodation plans.
Public	Barriers to accessibility are identified by individuals accessing programs and services offered by the school board. Members of the public may bring concerns to the attention of the school or the Board Office. The Rainbow District School Board website also provides an opportunity for feedback. Barriers identified by members of the public are referred to the Board's Accessibility Committee. Development of the Multi-Year Accessibility Plan and the ongoing feedback opportunities are additional important methods to identify barriers to accessibility.
Board Wide	Ongoing liaison with bargaining partners, provincial associations, school boards, and public sector agencies provides updates on emerging barriers to accessibility. SEAC, PIC and the Ontario Public Schools Boards Association are examples of some of the resources used for barrier identification. Review of our facilities provides up-to-date identification of barriers and permits planning to remove/prevent such barriers.

# Recent Barrier Removal Achievements that have been addressed under the previous Multi-Year Accessibility Plan(s)

- Procurement practices now incorporate accessibility criteria for goods, services and facilities.
- Ongoing accessibility awareness training has been/is provided for all Educators/classroom-based staff on accessible instruction and program delivery.
- Educational resources and materials, student records and information on program requirements in accessible formats are available upon request.
- Ability to respond to feedback to ensure accessibility to persons with disabilities and to provide accessible formats and communication supports upon request
- New websites and content meet WCAG 2.0 Level A standards.
- Human Resources procedures have been updated with regard to accommodating persons with disabilities.
- School transportation plans continue to be developed and reviewed with parents for students with disabilities.
- School libraries are able to provide accessible or conversion-ready formats of print resources upon request.
- The Board is able to provide information and communication supports upon request and in a timely manner to persons with disabilities.
- New school construction has adhered to the current building code and includes level access to schools, automatic door openers, elevators in schools of more than one floor, accessible washrooms. Details of accessibility by school is outlined in Appendix A.

# <u>Barriers to be addressed under the Multi-Year Accessibility Plan 2023-2027</u>

Rainbow Board intends, through this Multi-year Accessibility Plan for the period 2023-2027, to take action to address barriers to accessibility related to the Standards areas of current Regulations. This is in addition to ongoing training and ongoing work the Board is undertaking with regard to identification and removal of barriers in the Board's physical environment.

## 1. Welcome

Chair Shannon Ketchabaw welcomed everyone to the meeting and invited participants to put their name and school in the chat box.

## 2. Dare to Care Anti-Bullying Program

Presenters: Principal Brenda Carr, Valley View Public School Principal Jennifer Harvey, Lansdowne Public School

Valley View Public School and Lansdowne Public School joined together to pilot the Dare to Care Program in the 2022-2023 school year. They are among 12 schools piloting the bullying prevention program in Sudbury, Espanola and Manitoulin Island.

With modules for students, professional learning for staff, and resources for parents/guardians, Dare to Care engages the entire school community to work towards a common goal – transforming the silent majority into the caring majority. Students learn about the importance of being kind, the difference between bullying and mean moments, tattling versus asking for help, and standing up for yourself and others.

Prevention and intervention strategies focus on social emotional learning with an emphasis on empathy. Through the program, all stakeholders – including administrators, teachers, support staff, parents/guardians and students – gain a deeper understanding of bullying, and, more importantly, develop tools to create a caring community. Students learn to understand the difference between a mean moment, normal conflict and bullying. They also learn a shared language around discrimination, racism and cyberbullying. In the older grades, students are introduced to the effects of bullying on mental health, sexual harassment and cyberbullying, and bullying and the law.

The program also helps parents/guardians become allies in supporting their children through resources and videos on a Parent Portal. Dare to Care carefully defines the word bullying and stresses the importance of having a common understanding of the definition. Parents learn what bullying looks like, including the difference between normal peer conflict and bullying. Tips and guidelines are provided for parents to help their children make positive choices both online with social media and other technology and in their daily face-to-face interactions. During webinars, parents learn six non-reactive life skills that can be reinforced at home so children feel more confident and competent in dealing with bullying situations.

- D. Williamson shared that the decision to integrate is very individual to the student so it is difficult to provide an overall board mandate.
- W. Larouche shared that there is information on integration in the RDSB Special Education Plan available via the board website. W. Larouche asked that individual families seek this information from their individual school teams, beginning with the classroom teacher and working up from there.

K. Wachnuk shared that decisions around integration are made on an individual basis. These decisions are based on the student's levels and on what the individual school can provide regarding classroom support. In subject areas where the student is learning well below grade level their learning needs would be better supported in an Intensive Support Program environment to help close individual learning gaps.

SIP funding represents the largest source of funding from the Ministry of Education for Special Education at our board, typically receiving about \$8M to serve our students with the highest needs. Sue Del Riccio, retired RDSB Special Education Consultant, is contracted out to do these applications on behalf of our board.

In the spring of 2023 the Ministry of Education announced upcoming changes to SIP funding. These changes would mean a six percent overall increase, our board typically generates much more than that through the application process so this would be detrimental to our school board.

Superintendent Wachnuk shared that for now, school board's have now been given the decision to either go with the six percent increase or continue with the application process. Our board will continue with the application process for this school year. This funding is primarily used to fund Educational Assistants across our board.

J. Kosmerly inquired as to whether there are other school boards in the province who are being audited around SIP funding.

Superintendent Wachnuk shared that there was a change in the process of diagnosing Autism in the province. Previously students diagnosed with Autism underwent an ADOS Assessment to determine the diagnosis. These assessments were conducted by a team of three or more qualified professionals. In an effort to remove barriers to families they have changed the practice of Autism diagnoses to remove the need of an ADOS Assessment. Family doctors, Pediatricians, Nurse Practitioners and Psychologists can now provide Autism diagnoses so families are able to access funding and services through the Ontario Autism Program. There are now over 50,000 children registered with the Ontario Autism Program. The funding from the Ministry of Education to school boards has not changed in the province in line with this change in process for diagnosis. Specifically, Special Education Resource Teacher funding has not increased to support the increased number of students with Autism across the board.

- N. Delaney raised the issue that the RDSB IPRC definition of Autism does not align with the medical terminology and definition. Superintendent Wachnuk reiterated this issue and explained that the definitions of individual student identifications through the Ministry of Education do not align with the medical terms and definitions of these identifications. As a school board we are mandated to use the definitions of special education identifications as outlined by the Ministry of Education.
- J. Kosmerly wondered if it is too early to have SEAC recommend to the board to write a letter to the Ministry of Education advocating for increased financial support to schools in supporting the increased number of children with Autism.

Superintendent Wachnuk recommended waiting to see how this unfolds as the changes were only made this spring and consider gathering data on the increased number of students with Autism in our schools in the meantime. Superintendent Wachnuk suggested discussing this further later on this year in an upcoming SEAC meeting.

W. Larouche reiterated that the definitions used on the IPRC documents do come from the Ministry of Education, of which the Board is mandated to use.

#### 11.0 Special Education Staff Report

Principal Williamson shared an update on an additional Project Search site in Sudbury for the 2024-2025 school year. We are in the process of gathering data and feedback from past and current Project Search candidates to explore the viability of a second program. We may look at teaming up with the City of Greater Sudbury for a possible second Project Search site.

Principal Williamson shared information on preschool transition meetings for incoming children with special needs. We are looking to make changes to the timing of these meetings. During the 2022-2023 school year we ran over 100 preschool transition meetings to support incoming students with special needs from January to the end of June. The timing of the meetings posed an issue because staffing was completed in March.

Principal Williamson shared that updated Preschool Speech and Language (PSL) and Children's Rehabilitation Guidelines have been released. Historically community agencies (such as WordPlay) have provided speech and language services to children into their first year of Kindergarten. With the new changes community agencies will now only provide services up until they begin school. This will require a change in our service model for speech and language services through our board. Principal Williamson will keep SEAC informed of these changes moving forward.

#### 12.0 Board Report

Trustee Kosmerly shared that at the September Board Meeting trustees received a presentation on summer 2023 programming that was offered. The Board also approved an appointment process to fill the position of Trustee. The closing date for applications is October 17, 2023 and more information is available on the board website.

Trustee Kosmerly shared that several events took place on September 28, the National Day for Truth and Reconciliation to recognize and commemorate the legacy of residential schools. Trustee Kosmerly attended the Sunrise Ceremony held at the Rainbow District School Board Office on Wembley Drive.

#### 13.0 Chairperson's Remarks

W. Larouche shared that any associations networking with families please encourage them to fill in the parent feedback survey to communicate suggestions for improving special education programs and services at the Rainbow District School Board. This survey is available in paper copy as well as online via the board website.

#### 14.0 Association Reports

March of Dimes Canada - J. Way

October is National Disability Employment Awareness Month. On October 19 the March of Dimes is planning the "Light It Up" event, where landmarks across Sudbury will be lit up in support of National Disability Employment Awareness. Individuals are encouraged to wear blue and purple to support the cause and share pictures via social media.

October 22 at 11:00 am at Lockerby Composite School.

Our Children Our Future (OCOF) - N. Delaney

N. Delaney is now on the Our Children Our Future Board of Directors. She is hoping to connect daycares to our schools in further supporting children with special needs in our community.

Learning Disabilities Association of Sudbury (LDAS) - W. Larouche October is Learning Disabilities Month. They will be hosting a variety of events this month in support of learning disabilities awareness. LDAS will be planting blue flags along Paris Street next week. They will also be lighting up the Big Nickel on October 10. On October 14 they will be hosting a session with Cambrian College and the Sudbury Five to have all children come and play with the Sudbury Five players. On October 17, Krissy Bouthillier will be providing an assistive technology workshop at Lockerby Composite School in the evening, all

are welcome to the event. Lastly, LDAS will be hosting a Halloween-themed Wolves Game on October 27. Discounted tickets can be purchased for \$18 each, children 10 and under can be purchased for \$10.00.

#### 15.0 Correspondence Addressed to SEAC

W. Larouche discussed an email from a parent of a student with special needs who attends the Rainbow District School Board regarding how special education students receive music programming. D. Williamson shared that when possible, we want to integrate students into the regular program for authentic learning experiences. We are often looking at secondary subjects, like Music, Art, and Physical Education. This is not always the best fit for all students, and needs to be decided on an individual student basis. The Music program differs significantly from school to school in our elementary schools.

#### 16.0 Other Items/ Future Agenda Items/ Information Requests

 Revisit SEAC making a recommendation to have the board write a letter to the Ministry of Education about supporting the increased number of students with Autism in our schools.

#### 1. Welcome from Senior Administrator Leslie Mantle

Senior Administrator Leslie Mantle welcomed everyone to the Annual General Meeting. Administrators at each site - Sudbury, Espanola and Manitoulin - read a land acknowledgement. She reviewed the agenda for the evening and introduced members of the 2022-2023 PIC Executive. She also introduced the administrators, teachers and Trustees who participated in PIC. She acknowledged all of the parents who attended PIC meetings and thanked them for their interest and support.

#### 2. Greetings from Board Chair Bob Clement

Chair Clement extended a warm welcome to everyone in Sudbury, Espanola and Manitoulin. He indicated that School Councils are among the many ways we build connections between the school and the home and thanked parents/guardians for being involved in their child's school and their child's education.

"What did we do to help our children through school?" he asked. "We were always there." We attended school events, we joined school committees, we went to basketball games and concerts, we set time aside at home for reading, homework and projects. We were actively involved in our children's education - at school and at home. Children demand our time, our attention and our energy. Chair Clement said "being there" just like you are "here" this evening is an important part of being a parent.

He added that sending kids off to school is not the end, it's just the beginning. We want parents to know what's happening at their child's school. We want parents to ask their children what they are learning and how they are doing, and to practice skills - like reading, writing and math - at home. Just like practice makes perfect, parental involvement improves student achievement.

Chair Clement acknowledged Shannon Ketchabaw of A.B. Ellis Public School and Melissa Gladu of Northeastern Elementary School for serving as Chair and Vice-Chair of PIC over the last school year. He also acknowledged the parents/guardians who put their names forward to be on PIC in this school year, and thanked them for answering the call to serve.

#### 3. Greetings from Director of Education Bruce Bourget

Director Bourget thanked parents/guardians for attending the PIC AGM. He said their presence sends a strong message - you value education – and that goes a long way in contributing to our shared purpose.... *Together, we prepare students to become lifelong learners, achieving their full potential as confident, caring members of society.* 

He said it is an honour for him to work on behalf of children and all of the students that we serve in Rainbow Schools in Sudbury, Espanola and Manitoulin Island. Director Bourget said he visits schools on a regular basis and is always inspired by what he sees in our classrooms - especially in reading, writing and math which are the foundation for all learning.

#### 1.0 Welcome and Introductions

W. Larouche welcomed all members to the virtual meeting. Members introduced themselves to the committee. Superintendent Wachnuk welcomed new Trustee McCauley to the SEAC committee.

#### 2.0 Establish Quorum of Voting Members

#### 3.0 SEAC Mission Statement

G. Cacciotti read the mission statement aloud.

#### 7.0 Business Arising

No business arising.

#### 8.0 New Business

Principal Williamson shared the Special Education EQAO results from the 2022-2023 school year. These include students who are exceptional students under the categories of Learning Disability, Autism, Language Impairment, Physical Disability, Mild Intellectual Disability, Developmental Disability and Behaviour. The results do not include students who are identified as Gifted. The Rainbow District School Board had the top results in Primary reading (50% vs the Provincial 47% at level 3), Primary writing (3% away from the Provincial average) and Primary math (4% away from the Provincial average). At the Junior level, the students' scores improved in reading by 4% from the previous year and outperformed the province by 6%. The reading interventions that are being implemented in the Rainbow Board include Empower, Levelled Literacy Intervention (LLI), Remediation+ and Spell Read. In writing, 57% of the Junior special education students achieved level 3 while 21% achieved level 3 in mathematics, resulting in a 10% increase from last year.

At the Secondary level, there were 262 students with special education needs who participated in the OSSLT. 56% of the Rainbow District School Board students achieved the provincial standard. Students are supported through transition meetings from grade 8 to grade 9, LLI, Empower and Spell Read. They also receive assistance in the classroom, resource room as well as with Educational Assistant support.

Grade 9 special education students achieved a 20% success rate in math versus 27% at the provincial level.

- J. Contini asked if EQAO standards are different for students with special needs. Superintendent Wachnuk responded that all students who follow the Ontario Curriculum have the opportunity to write EQAO. The students' accommodations are provided to them based on what is in their IEP.
- W. Larouche commented on how Rainbow is above the average of the coterminous boards.

#### 9.0 Requests for Leaves of Absence

S. Kitlar-Pothier, S. Roussy, and R. Silvestri requested a leave of absence from the December 6, 2023 SEAC meeting.

#### 10.0 Superintendent's Report

Superintendent Wachnuk shared the provincial revisions that were made in regards to diagnosing children with autism. They have expanded the health professionals (nurse practitioners, doctors, pediatricians, psychometrists, etc.) that can diagnose autism. Boards are now expected to receive more students with the diagnosis of autism prior to entering school. We have not heard whether boards will receive additional funding to support this new change.

Superintendent Wachnuk recommended that SEAC wait until the spring before writing a letter to the Ministry to voice concerns and request an increase in funding that will correlate with the influx of students being diagnosed with autism who attend RDSB schools.

Superintendent Wachnuk shared an update regarding SIP (Student Incident Portion). SIP funding comes from the Ministry of Education on an annual basis, to support the students who have the most significant needs. The past practice has been that school boards complete annual applications to be considered for additional funding. The boards need to show that the students require two on one support. The two categories that are considered for the SIP funding are medical needs and safety needs. Students with behavioural challenges fall under the safety needs category. The Rainbow District School Board has always done a great job with the application process and consistently generated great funding to support our students with higher needs. In August 2023, RDSB received over 8 million dollars through SIP funding.

Superintendent Wachnuk shared that the Ministry changed the SIP process when COVID arrived. The school boards received a 6% increase instead of having to submit the applications. In April of 2023, the school boards received a memo to inform them that they would be receiving the 5% + 1% for administrative fees moving forward. This is concerning for Rainbow because RDSB typically receives 20% annually while the average school boards receive 11% annually.

Superintendent Wachnuk explained that the initial message was that the school boards would be given the choice to either accept the 6% increase or continue with the SIP application process. This, however, is not the case. Superintendent Wachnuk spoke openly and publicly at the Ontario Council for Special Education

regarding her concerns around the changes to the funding to special education and how detrimental this would be for RDSB students.

Superintendent Wachnuk shared that RDSB is being audited for SIP and SEA this school year. The Ministry will be visiting Jean Hanson Public School and Churchill Public School as part of the audit. February 1st, 2024 will be the first audit meeting with the Ministry. It will be held virtually. February 23rd, 2024 the Ministry will be present at the two schools and February 28th, 2024 will be the final audit meeting, held virtually. Superintendent Wachnuk shared that the audit will give RDSB the opportunity to advocate for their preference for the SIP application process.

Trustee McCauley asked if the SIP application is done on an individual basis to which Superintendent Wachnuk explained that we have to select the best student candidates for the funding. The Ministry then decides on the amount that is provided, \$28 000 being the maximum. This amount does not cover the cost of a half time Educational Assistant. Trustee McCauley expressed that this is a labour intensive process and that it is easier for the Ministry to simply allocate a base amount. Trustee McCauley highlighted that the government is saving 14% of the dollar figure. He also inquired if this percentage can be translated into dollar amounts in order to have a better understanding of how detrimental this is for the Rainbow District School Board.

Superintendent Wachnuk shared that she and Principal Williamson are looking at numbers. They have determined that the change of funding would mean a loss of approximately five Educational Assistants. This means that there will be 10 students underfunded in the Rainbow board. This is significant and devastating for our students.

Superintendent Wachnuk explained that the accountability factor would go out the window with the new funding as up until now, the dollars came attached to a student's name. Through the application process, boards needed to make sure that the dollars were spent for the needs of those individual students for which the board applied for. If a student moved, that support would go with that student because of the old SIP process.

Trustee Corbiere-Addison expressed that she would be happy to join her fellow Trustees during the Ministry's audit in order to advocate for the Rainbow District School Board.

On November 24th and 25th, Superintendent Wachnuk and Principal Williamson attended the CEC in Toronto. They attended sessions which included topics on ABA, inclusion in school boards and pediatrician involvement in schools. Superintendent Wachnuk expressed that in comparison to other school boards, the Rainbow District School Board is leaps and bounds ahead.

Superintendent Wachnuk shared information regarding Project Search. RDSB has a partnership with March of Dimes and HSN to give students an opportunity to complete their school year at HSN as part of the internship program. March of Dimes provides support workers to ensure that the students are supported and successful. All of the students in the program last year are now employed in the community. Superintendent Wachnuk shared that the students from Project Search have so much to contribute to the work world. Their sense of belonging and their sense of being productive citizens have been affected in a positive way due to this program. Superintendent Wachnuk also shared a letter from an HSN employee regarding his experience working with a student from Project Search. This opportunity gave as much to the employee at HSN as it did to the student. RDBS is very grateful for the partnerships with HSN and March of Dimes. Trustee Corbiere-Addison expressed interest in having the program extended to Manitoulin Island.

Superintendent Wachnuk shared that this is G. Cacciotti's last SEAC meeting. C. Burke will fill in for the position of secretary for SEAC in her absence.

Trustee McCauley provided a Board Report from the latest Board Meetings. Trustee McCauley joined his first Board Meeting as Trustee on November 21, 2023. Dave Farrow assumed the Chair position replacing Bob Clement who stepped down as Chair. Director Bourget presented the Board's Annual Report at the December 5, 2023 Board Meeting. The audited financial statements were also presented and approved by the Board at the December 5, 2023 meeting. Lastly, congratulations were expressed by the Board to the coach and players of the Lasalle Volleyball Club who are OFSAA champions once again.
