Emily Anstice, a Grade 3 student from Assiginack Public School, captured third place in the Primary category at the **Spelling Bee of Canada National Championships** held in Toronto last month. She won the honour to compete nationally by winning the Regional Spelling Bee Competition in Sudbury. Three events will be held over the course of the weekend including a music night at La Fromagerie Elgin, an Art-stravaganza at the school and a brunch at Idylwylde Golf & Country Club. BY-LAW NUMBER: 2025-01

A BY-LAW authorizing the Rainbow District School Board (the "Board") to borrow money pursuant to the provisions of section 247 of the Education Act (the "Act") for the raising of funds to finance certain permanent improvements as more particularly described in this By-Law.

WHEREAS:

- A. The Board has authorized the permanent improvements under the: School Condition Improvement Funding Program \$12,286,143
- B. The Board wishes to apply to the Canadian Imperial Bank of Commerce ("CIBC") for a short term capital loan through the purchase of Bankers Acceptance for the purpose of financing the permanent improvements;
- C. The total cost of the projects is within the Board's Debt and Financial Obligation Limit as established by the Ministry of Education.

THEREFORE, BE IT RESOLVED as follows:

- 1. The Treasurer and the Deputy Treasurer of the Board are authorized on behalf of the Board to borrow \$12,286,143 for permanent improvements in accordance with the Act, plus interest at a rate to be agreed upon from time to time with the CIBC and consistent with the short term borrowing direction provided by the Ministry of Education.
- 2. The Treasurer and the Deputy Treasurer are authorized for and on behalf of the Board to execute and deliver all such other documents and to do such other acts and things as may be necessary to give full effect to this By-Law.
