She has also supported Lasalle's Sport Health Academics and Leadership Program (SHAL) by helping out with tournaments and special events.

And she was President of the Student Council this year.

Izabella believes - and I quote - "Involvement in school and school life is extremely important as you get to experience new things and meet new people, which can lead to lifelong relationships. You also get to develop your strengths, such as leadership, confidence, responsibility and time management."

Grade 6 students from R.L. Beattie Public School took their learning outdoors to participate in a bog restoration project within their school community. Students studied the biodiversity of a nearby ecosystem and learned about the critical role bogs play in storing carbon and supporting wildlife. Great work!

Dane Gibeault, a Grade 12 student from Lo-Ellen Park Secondary School, received a Canadian Tooling & Machine Association High School Award. Congratulations, Dane!

Earlier this month, Rainbow Schools garnered gold and silver at the annual Mock Trial Competition. The Hennessy Cup was awarded to Lasalle Secondary School Team #2, and silver medals were presented to Sudbury Secondary School Team #1. The Competition is an outstanding example of how community partnerships enrich student learning.

Copies of the book *T is for Terry: An ABC of Courage* - an illustrated children's book inspired by the life of Canadian hero Terry Fox - have been distributed to libraries across Rainbow elementary schools thanks to a generous donation from the City of Lakeshore Chapter. This story will serve as an inspiration to students for years to come and remind us why we continue to honour Terry Fox's legacy.

In keeping with reading, Westmount Avenue Public School received a \$10,000 grant from the Indigo Love of Reading Foundation to expand its school library. Funds will be used to create a welcoming space for students to learn and explore, and purchase a variety of books to support diversity, inclusion and essential social skills.

A shared commitment to the community brought students from R.L. Beattie and Lo-Ellen Park together to build and decorate custom benches for Extensicare Countryside. These were truly made with caring hands and kind hearts.

Six students from the Rainbow District School Board participated in the first ever OYAP Level 1 Carpentry class offered in partnership with the Local 2486 Carpenters Union. They now have a head start on their careers. This is another wonderful example of the power of partnerships.

New playground equipment was unveiled at Walden Public School thanks to the leadership of the School Council and incredible community support. Staff, students, families and community sponsors gathered for the official ribbon-cutting ceremony on June 19, 2026.

Rainbow Schools, once again, achieved 100 per cent EcoSchools certifications, a reflection of our ongoing commitment to environmental education and sustainability. Congratulations!

Staff and students from Lansdowne Public School cycled their way to victory in the City of Greater Sudbury's 2026 Bike to School Week Challenge, recording an impressive 592 active transportation trips - the highest total among all participating schools. Well done!

BORROWING RESOLUTION**

A RESOLUTION AUTHORIZING THE BORROWING OF MONEY TO MEET CURRENT EXPENDITURES OF THE RAINBOW DISTRICT SCHOOL BOARD (THE “Board”)

- A. In accordance with Subsection 243(1) of the Education Act (R.S.O. 1990) (the “Act”), the Board considers it necessary to borrow the amount of up to Seven Million Dollars (\$7,000,000) to meet, until current revenue is received, the current expenditures of the Board for the period commencing on September 1, 2026 and ending on August 31, 2027 (the “Period”).
- B. Pursuant to Subsection 243(3) of the Act, the total amount borrowed pursuant to this Resolution together with the total of any similar borrowings and any accrued interest on those borrowings is not to exceed the unreceived balance of the estimated revenues of the Board for the Period.
- C. The total amount previously borrowed by the Board pursuant to Section 243 that has not been repaid is \$0.
- D. The amount borrowed for current expenditures is within the Board’s Debt and Financial Obligation Limit as established by the Ministry of Education from time to time.

RESOLVED THAT:

- 1. The Chair or Vice Chair and the Treasurer are authorized on behalf of the Board to borrow from time to time by way of promissory note, or overdraft, or bankers’ acceptance from Canadian Imperial Bank of Commerce (“CIBC”) or from any other approved lender authorized for borrowing purposes in accordance with Section 243 of the Act a sum or sums not exceeding in the aggregate Seven Million Dollars (\$7,000,000) to meet, until current revenue is collected, the current expenditures of the Board for the Period (including the amounts required for the purposes mentioned in Subsection 243(1) and 243(2) of the Act), and to give to CIBC or to any other approved lender promissory notes or bankers’ acceptances, as the case may be, sealed with the corporate seal of the Board and signed by any two of the Chair or Vice Chair and the Treasurer for the sums borrowed plus interest at a rate to be agreed upon from time to time with CIBC or any other approved lender;
- 2. The interest charged on all sums borrowed pursuant to this Resolution plus any related charges, is not to exceed the interest that would be payable at the prime lending rate of the chartered banks listed in Schedule 1 of the Bank Act (Canada) on the date of borrowing;
- 3. The Treasurer or Deputy Treasurer is authorized and directed to apply in payment of all sums borrowed plus interest, all of the moneys collected or received in respect of the current revenues of the Board;
- 4. The Treasurer or Deputy Treasurer is authorized and directed to deliver to CIBC or any other approved lender from time to time upon request a statement showing (a) the total amount of unpaid previous borrowings of the Board for current expenditures together with debt charges, if any, and (b) the uncollected balance of the estimated revenues for the current year or, where the estimates have not been adopted, the estimated revenues of the previous year less any current revenue already collected.
